On September 14, 2020, Michigan Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD) staff Kaitlyn Leffert confirmed that Lyon Sand and Gravel is no longer operating a permitted portable crusher under a voided permit. The crusher was identified by Source Registration Number (SRN) of N5337. The purpose of this activity was confirm that the crusher was no longer operating, as well as compliance with the Federal Clean Air Act; Article II, Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); AQD administrative rules.

Facility History

Lyon Sand and Gravel was issued permit to install (PTI) No. 364-93A in 1993, which was subsequently voided on December 20, 2000. The crusher was originally permitted to operate at 51777 W 12 Mile Road, Wixom, MI. Based on our records, the Wixom address was considered to be the home base for that crusher and while it did occasionally move to other locations, it appeared to operate at this site the majority of the time that the permit was active. This location is currently the site of the Cadillac Asphalt Wixom Plant (SRN: B1960). The current inspector for the Cadillac Asphalt Wixom plant is Robert Joseph and his most recent inspection of the site was in October 2019. I contacted Robert to ask if he recalled seeing any portable crushers on the site while conducting his inspection. He said that he did not observe any portable crushers operating at the Wixom site during his last visit.

Another address associated with the site in MACES is 1950 Inwood Road, Washington Township, MI. This address appears to also have been a previous site of an American Aggregates operation (SRN: N6386) that appears to have since been closed. The permit for the American Aggregates site was voided in July 2006. Google Maps imagery from 2020 does not show any equipment located at this site.


Discussion with Company

On September 11, 2020, I contacted Lyon Sand and Gravel regarding the operating status and location of this crusher. On September 14, 2020, I spoke on the phone with Alicia Ramsdell, Environmental Engineer, Edward C. Levy Co (the parent company of Lyon Sand and Gravel). She informed me that they had not maintained the file of that crusher, except for the documentation that the permit had been voided. Without any further information to specifically identify the crusher, she was not sure if the crusher continued to operate under a different permit. However, she was certain that all their crushers are permitted and there are not any crushers operating under the voided permit. Later the same day, she emailed me to state that to the best of her knowledge, the crusher no longer exists.

Conclusion

Based on the available information and the discussion with the company, the portable crusher operated by Lyon Sand and Gravel does not appear to be operating under the voided permit. The permit has already been voided and therefore no additional action is needed at this time.
