## **VIOLATION NOTICE**

On August 20, 2014, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of Pioneer Metal Finishing ("Pioneer") located at 24600 Industrial Highway, Warren, Michigan. The purpose of this inspection was to determine Pioneer's compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the administrative rules; the conditions of Permit to Install (PTI) number 2-03L; the conditions of Renewable Operating Permit (ROP) number MI-ROP-N5747-2011a; and Consent Order AQD number 19-2010 dated August 17, 2010.

During the August 20, 2014, inspection, staff observed the following:

During this inspection, Pioneer Metal Finishing was unable to produce the emission records and the required calculations. The calculations are performed only up to May 2014. The calculations are required to be completed by the 15<sup>th</sup> day of each calendar month for data corresponding to preceding month.

This is a violation of the recordkeeping and emission limitations specified in Special Condition number FG-LINES, VI.1 of PTI number 2-03L.

The cited Special Condition numbers FG-LINES, VI.1 and FG-PARTSWASHLINES, IV.2 of PTI number 2-03L and MI-ROP-N5747-2011a are also enforceable as paragraphs 9A, 9B, 12 and 17 of Consent Order, AQD number 19-2010.

Please initiate actions necessary to correct the cited violations and submit a written response to this Violation Notice by September 17, 2014 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If Pioneer believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.

Thank you for your attention to resolving the violations cited above and for the cooperation that was extended to me during my inspection of Pioneer.
