On 9/24/2014 I conducted an unannounced inspection of this portable gravel crusher located just Northwest of Engadine at the Butkovich Pit on Linck Road in Mackinaw County. PPE worn during the inspection included steel toed boots, safety vest, safety glasses, hearing protection and hardhat.

The crusher was in operation at the time of my inspection. My contact at the site was Gene Brow & Sons employee and foreman Dwayne Jordan. Mr. Jordan informed me that they had crushed approximately 2500-2800 tons at their present location as they had only been on site for one day. Mr. Jordan could not locate their copy of PTI# 371-07A in the equipment trailer, however I did receive a phone call from the crusher owner, Mr. Brow, directly after my inspection. Mr. Brow had left the site just prior to my arrival and he informed me that he had the copy of the permit in his work vehicle. I informed Mr. Brow that it was required to have a copy of the permit on site. He responded that he would post the permit in his equipment trailer immediately.

Spray bars were in use and water was being supplied by a 275 gallon IBC tote. Water was sourced from the adjacent farm owned by the Butkovich's.

Equipment in use on site included:

- Primary Crusher (# 2-1)
- Cone Crusher (#2-2)
- 36" Conveyor (#2-5)

All equipment is covered under air use permits issued to Gene Brow & Sons.

I did not observe any violations of the air pollution control rules or PTI# 371-07A during this inspection.

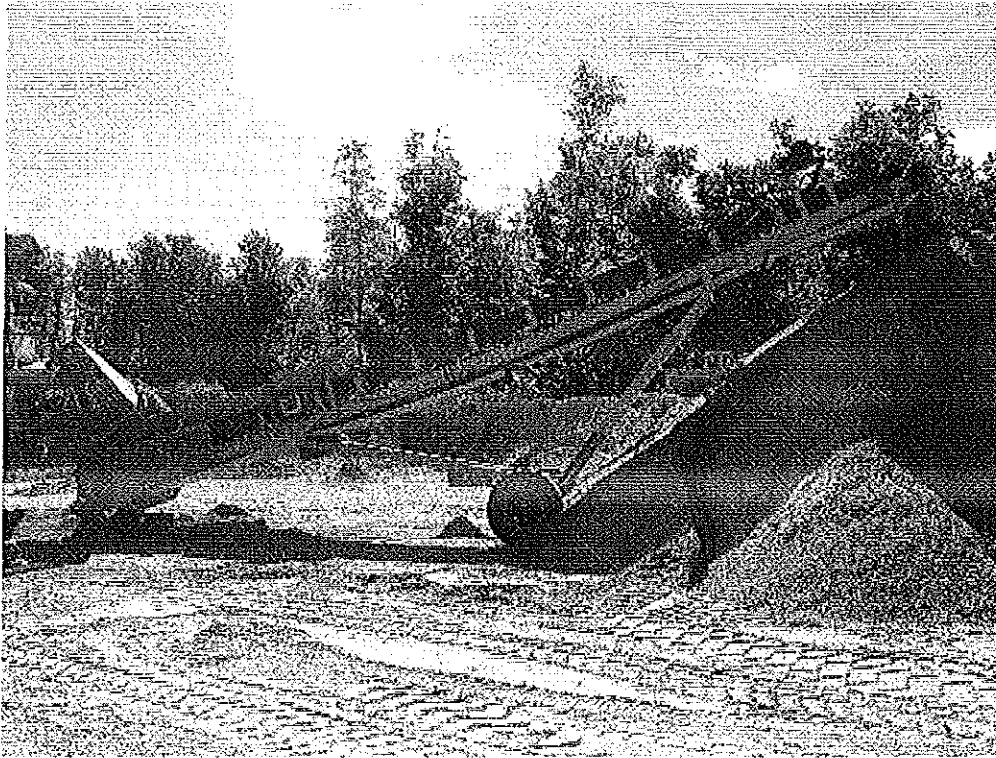


Image 1(GB1) : Conveyor 2-5

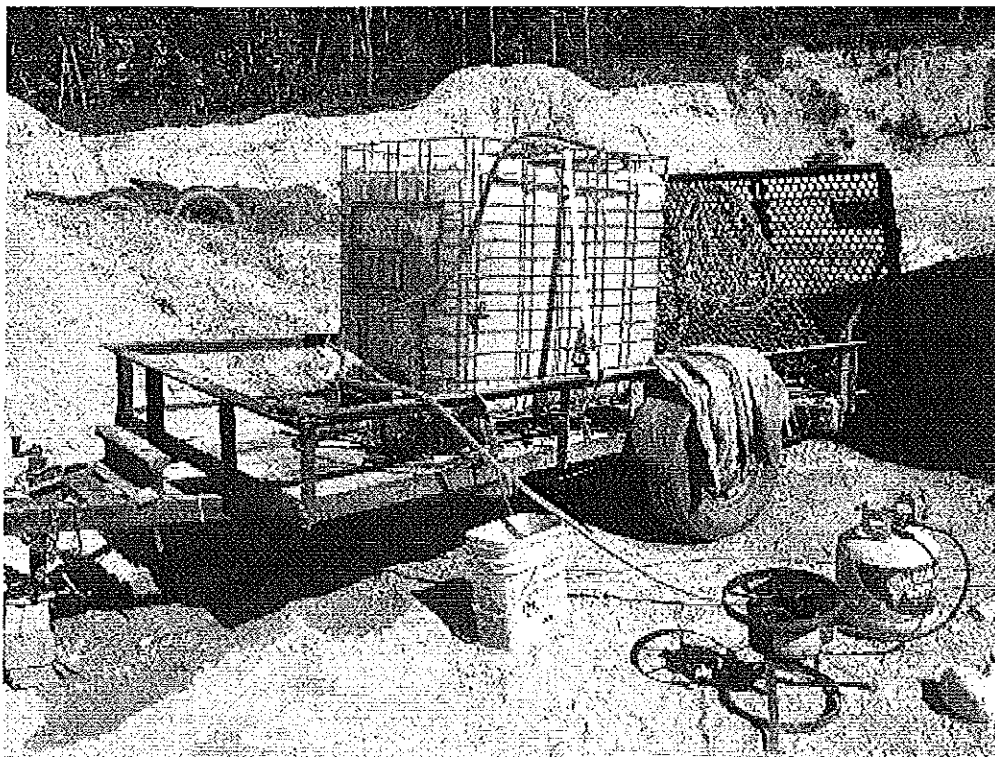


Image 2(GB2) : Water supply--275 gallon IBC tote



Image 3(GB3) : Screen 2-2

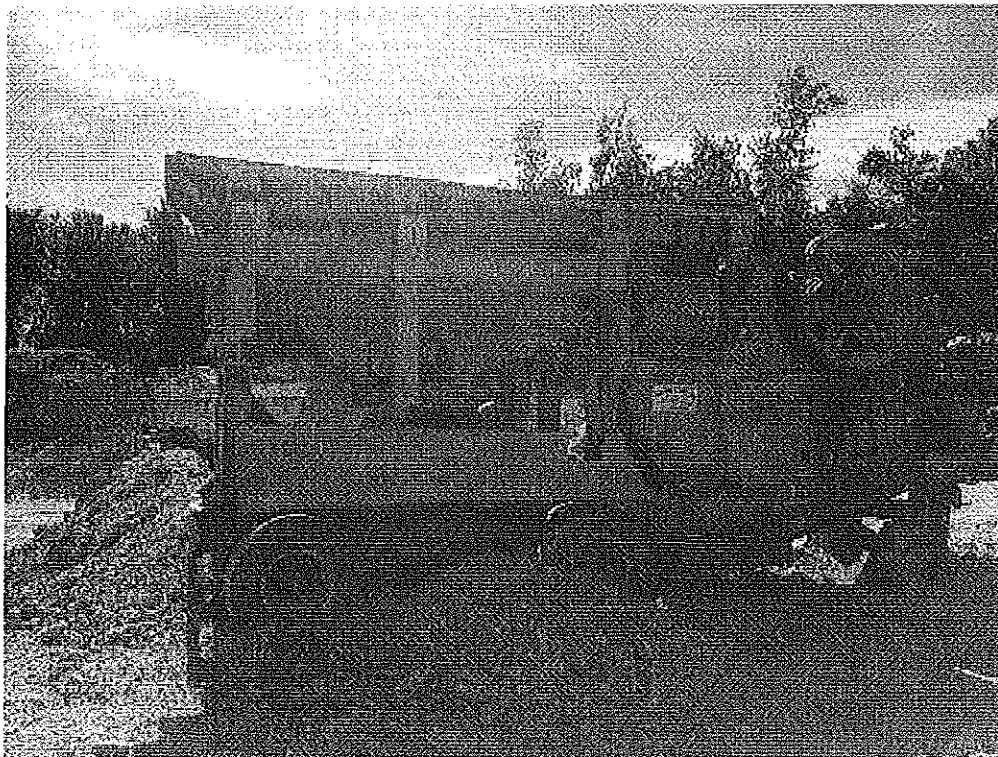


Image 4(GB4) : Jaw 2-1
