LOCATION: East Lake Pit (owned by Luce County), approximately 4 miles east of McMillan, south side of M-28, Luce County. Pit is located in a rural area.

INSPECTION: On 8/26/2015 I conducted an unannounced inspection of this portable gravel crusher. PPE worn during the inspection included steel toed boots, safety vest, safety glasses, hearing protection and hardhat.

The crusher was not in operation at the time of my inspection; the crew was still in the process of setting up on site. My contacts at the site were Gene Brow & Sons owner Mr. Dean Brow and foreman Mr. Dwayne Jordan. Mr. Brow informed me that they would be up and running by that afternoon (8/26/15). Mr. Brow located a copy of PTI# 371-07A in the equipment trailer. Water was being supplied by a 275 gallon IBC tote and sourced from a creek adjacent to the pit. I did not observe any fugitive dust issues and the department has not received any complaints regarding this facility.

Equipment in use on site included:

- Primary Crusher (# 2-1)
- Cone Crusher (#2-2)
- 36" Conveyor (#2-5)

All equipment is covered under air use permits issued to Gene Brow & Sons.

SUMMARY: I did not observe any violations of the air pollution control rules or PTI# 371-07A during this inspection.
