Mr. Grinstern:

Fremont Community Digester has been operating two reciprocating combustion engines (EUICENGINE1 and EUICENGINE2) at 1634 Locust Street, Fremont, Michigan according to the Permit To Install (PTI) No. 378-08A, granted to Fremont Community Digester, LLC The PTI requires initial performance testing in accordance with 40 CFR Part 60, Subpart JJJJ, unless the engines have been certified by the manufacturer. MDEQ provided a violation notice to Fremont Community Digester on February 25, 2014 that Fremont Community Digester (FCD) is in violation of the PTI. It is not the intention of Fremont Community Digester to operate the engines in violation of the PTI and is taking actions to correct the violation as soon as possible. EUICENGINE1 has operated for 4547 hours and EUICENGINE2 has operated for 3116 hours as of February 28, 2014.

FCD contacted the supplier Inland Power Group regarding the certification of EUICENGINE1 and EUICENGINE2 at FCD. The engines were started up on December 27, 2012 and the testing was to be conducted within I year of start-up. We were informed by Inland Power Group that these engines were certified and therefore further testing was not needed. A document showing the certification was provided to Fremont Community Digester and therefore FCD decided not to do the performance testing. However it was later determined by Inland Power Group that the document provided to FCD was in error. This resulted in the violation.

FCD was informed by MDEQ verbally on February 21, 2014 that testing is needed for the engines. Following have been or will be completed as soon as possible to correct the violation.

- 1. FCD has contracted with Derenzo and Associates, Inc to develop the test procedure and conduct the tests as required by PTI.
- 2. The test procedure will be submitted to MDEQ for review by March 19th 2014

.

3. The testing will be conducted on April 29, 2014.

FCD did not conduct the tests due to the wrong information provided by the engine supplier and
* FCD respectfully requests MDEQ to provide some time to rectify this violation. FCD is aware of the requirements of the PTI and will comply with all the requirements in the future. The next testing will be performed within 8760 hours or 3 years after April 29, 2014 whichever occurs first.
