**VIOLATION NOTICE**

On July 12, 2017, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of the Greaves Trucking Inc. Buzzell Road Pit located in Gladwin, Gladwin County, Michigan. The purpose of this inspection was to determine if the permitted non-metallic mineral crushing plant was being operated in compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the Air Pollution Control Rules; and the conditions of Permit to Install (PTI) number 260-10.

During the inspection, staff observed the following:

Process Description	Rule/Permit Condition Violated	Comments
FGCRUSHING	Condition 1.7	No spray bar installed
FGCRUSHING	Condition 1.2(b) and/or (c)	Due to failure to install and operate dust control required in condition 1.7, Visible Emissions were present exceeding limits for crusher and/or screen identified during EU operations.

Please initiate actions necessary to correct the above cited violations and submit a written response to this Violation Notice by August 7, 2017 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates that the violations have occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations (i.e. installation of the required spray bar to control fugitive dust from the crusher and/or screen) and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.
