Dear Ms. Luplow:

In response to EGLE's AQD Violation Notice dated September 17, 2020 concerning our crushing operations at Childers Excavating 920 East Gier Street, Lansing, Michigan, we have the following responses:

In specific response to your request that answers be provided to certain questions, we state the following:

Dates the violation occurred.

Dynamic Crushing operated crushing equipment from September 14th and September 15th for a total of approximately 12 hours without a current Permit. Crushing on these 2 days was performed in accordance with Site Specific Permit from 2019, recognizing and within approved hours of operation and with required dust suppression measures. The crushing equipment was shut down on September 16, 2020 upon completion of the site inspection by EGLE.

Explanation of the causes and duration of the violation.

Violation occurred as result of misinterpretation or lack of understanding of the effective dates for previously issued Site Specific permits. We had assumed we could operate under the permit issued in 2019.

Whether the violation is ongoing

The violation is not ongoing. The crushing equipment was shut down on September 16, 2020. Dynamic Crushing received on 9/24/20 Permit to Install No. 112-20 for Dynamic Crushing LLC, effective September 24, 2020 and resumed crushing on September 25, 2020.

Summary of the actions that have been taken and are proposed to be taken to correct the violation.

Upon notification of violation Dynamic submitted for approval a new permit application on September 18, 2020. Permit to Install No. 112-20 for Dynamic Crushing LLC, was approved, effective September 24, 2020.

Applications were submitted and Permit to Install approved on September 24, 2020. We now have a better understanding of the need to make new submissions for each current project and not rely on previously approved permits, regardless of the time frame.
