SOURCE DESCRIPTION

Portable nonmetallic mineral crusher operating under General PTI# 171-16.

Process equipment includes crushers, drills, screening operations, conveyors, loading, storage bins, and material handling equipment. Water spray bars are required on each crusher and screen with the option of a baghouse.

EMISSION LIMITS

PTI# 171-16 has visible emissions (opacity) limits for the following:

- Crushers - 15%
- Screens - 10%
- Rock Drills - 5%
- Conveyors/transfer points - 10%
- Screens and downstream equipment - 0%
- Equipment controlled by a baghouse - 7%
- Loaders & truck traffic - 5%
- Material storage piles - 5%
- Other related process equipment - 10%

MATERIAL USAGE LIMITS

Materials processed are limited to 2 million tons per year.

PROCESS/OPERATION LIMITS

Facility shall not operate unless fugitive dust plan is being implemented.

MONITORING

Daily and annual records of amount of material processed at each site where the facility operates.

INSPECTION

Upon confirmation with Ms. Carolyn Lurvey, Environmental Engineer/EEO Officer for Pitlik and Wick, Inc., this facility has not operated in Michigan since November of 2016, which was the only time it has operated in Michigan. It has been moved to Wisconsin and is operating there. It is not expected to relocate to Michigan in 2019. See attached email.
