Summary of Facility Visit and Compliance Status:

Reemco, located at 11801 Belden Court, Livonia, Michigan, was identified as a targeted inspection for 2019 due to the close proximity to ambient air trichloroethylene (TCE) concentrations that were detected as part of the Ford Beacon Project indoor air monitoring at addresses along Belden Court. For information regarding the ambient air sampling conducted as part of the Ford Livonia Transmission Plant remedial investigation, please see SRN A8645, MACES report CA A864547612. There are no records of air quality permits on file for this facility.

On July 31, 2019 Mr. Todd Zynda and Ms. Rebecca Loftus arrived at 1:54 PM at 11801 Belden Court and were greeted by Mr. Rick Schultz, Owner. According to Mr. Schultz, operations at the location are precision grinding, gauge and fixturing, and prototype tooling for the automotive and air craft business. Operations include machining and grinding equipment. During the inspection the machining and grinding equipment were observed. Any potential emissions are released to the general in-plant environment. The machining and grinding operations appear to be PTI exempt pursuant to R 336.1285(2)(I)(vi)(B).

According to Mr. Schultz, the facility does not operate any of the following equipment: boilers, cold cleaners, or emergency generators.

Operations at the facility appear to be PTI exempt. The source is considered to be in compliance.

Reemco also owns 11821 Belden Court, which according to Mr. Schultz is vacant (formerly Custom Vertical Unlimited [window blinds, etc]).
