February 21, 2024: The results of the samples collected showed sulfur content that varied greatly from the continuous monitor and stain tube results. The results demonstrated compliance (34.3 pph), however, the facility believed that the discrepancy between the testing results and the continuous monitor and stain tube samples resulted from an error at the third-party lab. The facility proposed to resample, which was completed on April 10, 2024. The samples from the April 10, 2024, event utilized a Tedlar bag, with the samples driven to a lab in Traverse City, MI. Sampling on April 10, 2024, showed the H2S as reported by the continuous monitor (10,790 ppm) and colorimetric indicator tube (10,666 ppm) to be slightly higher than the average total sulfur content reported for the samples analyzed via test method ASTM D5504 (10,390 ppmv). The mass emission rate calculated from the ASTM testing equates to 17.3 pph.
