Dear Nichole Jewell:

This letter is to notify you that your Permit to Install (PTI) application was received on October 25, 2024, to add a crusher to existing permitted equipment located at 5100 Hudson Road, Waterford, Michigan in Oakland County.

The tracking system has been initiated for the application identified as Application No. APP-2024-0258.

A final action on this application must occur on or before April 23, 2025, which is 180 days after receipt of the application if public participation is not required. If public participation is required, a final action must occur on or before June 22, 2025, which is 240 days after receipt of the application. These timeframes are outlined in R336.1206 (Rule 206).

It is the goal of the Air Quality Division (AQD) to process permit applications within the required timeframes; however, Rule 206 includes a provision for the applicant to request an extension to the processing period if approved by both the permit applicant and the AQD. An extension is effective after a formal agreement has been signed by both parties. VIOLATION NOTICE

On October 23, 2024, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD), conducted an inspection of Bell Site Development located at 5100 Hudson Road, Waterford, Michigan. The purpose of this inspection was to determine Bell Site Development's compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the Air Pollution Control Rules; and the conditions of Permit to Install (PTI) number 59-23.

During the inspection, staff observed the following:

Process Description	Rule/Permit Condition Violated	Comments
EU-PROCESS	PTI 59-23, General Condition 1 R 336.1201	Bell Site Development has modified the process equipment by installing an unpermitted crusher.

Please initiate actions necessary to correct the cited violation and submit a written response to this Violation Notice by November 21, 2024 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.


