VIOLATION NOTICE

On October 2, 2018, the Department of Environmental Quality (DEQ), Air Quality Division, performed an asbestos NESHAP (National Emission Standard for Hazardous Air Pollutants) complaint investigation at 13984 E W Avenue, Fulton, Kalamazoo County. The purpose of this investigation was to determine compliance with the requirements of Title 40 of the Code of Federal Regulations, Part 61, Subpart M (National Emission Standard for Asbestos), and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451).

According to my investigation, Wakeshma Township was the subject facility's controlling entity at the time of the demolition and Fink's Excavating, LLC, is the contractor who performed the demolition activities. The National Emission Standard for Asbestos holds both the owner and operator equally liable for any violations.

During the inspection, staff observed the following:

Demolition activities had taken place on the subject facility and the site was backfilled, graded and a lawn had grown in. No Notice of Intent to Renovate/Demolish was submitted to the administrator prior to the demolition activities.

Please initiate actions necessary to correct the cited violations and submit a written response to this violation notice by October 29, 2018, (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations, and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.
