On Friday, October 5, 2018, Michigan Department of Environmental Quality-Air Quality Division (MDEQ-AQD) staff, I, Adam Bognar, conducted an unannounced self-initiated inspection of D & D Machinery Movers located at 29461 Groesbeck Hwy, Roseville, MI. The purpose of this inspection was to determine the facility's compliance status with the Federal Clean Air Act; Article II, Part 55, Air Pollution Control of Natural Resources and Environmental Protection Act, 1994 Public Act 451; Michigan Department of Environmental Quality, Air Quality Division (MDEQ-AQD) rules; and Permit to Install Nos. 287-88 and 287-88A.

Permit to Install No. 287-88 was issued to Michigan Assembly Corporation in 1988 for a zinc primer dip tank and black water base prime dip tank. Permit to Install No. 287-88A was issued to Michigan Assembly Corporation in 1989 for a powder coat booth.

I arrived at the facility at about 2 pm. Michigan Assembly Corporation is no longer operating at this location. There is no longer any manufacturing taking place at this facility. D & D Machinery Movers stores industrial equipment for a variety of manufacturing industries. There are two warehouses at this location where equipment is stored: one warehouse at the above address, and another next door at 29469 Groesbeck Hwy, Roseville, MI. I was able to determine that the equipment associated with Permit to Install Nos. 287-88 and 287-88A has been removed.

**Compliance Determination** 

This facility appears to be in compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); and Michigan Department of Environmental Quality-Air Quality Division (MDEQ-AQD) Administrative Rules. On October 8, 2018, an email was sent to MDEQ-AQD permit section to void Permit to Install Nos. 287-88 and 287-88A.
