VIOLATION NOTICE

On July 24, 2018, the Department of Environmental Quality (DEQ), Air Quality Division (AQD) performed an asbestos inspection at 2933 Jefferson Street, Muskegon, Muskegon County, Michigan. The purpose of this inspection was to determine compliance with the requirements of Title 40 of the Code of Federal Regulations, Part 61, Subpart M (National Emission Standard for Asbestos), and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451).

According to our investigation, Mr. John Bodbyl (owner) of JMB Demolition, LLC was the operator who conducted the asbestos abatement, and the Muskegon County Land Bank is the property owner of the addressee mentioned above. The National Emission Standard for Asbestos holds the <u>owner</u> and <u>operator</u> liable for all violations.

During the investigation staff observed/discovered the following:

The subject property at 2933 Jefferson Street had asbestos abatement conducted to remove heat ducts covered with thermal systems insulation (TSI), and to abate the plaster walls and ceiling. During my inspection, I found remnants of TSI at two locations where the ducts were abated. I also found plaster pieces in different locations within the house, such as, the heat ducts and the kitchen ceiling, where a false ceiling was built over the top of the existing plaster ceiling.
