On February 19, 2014, AQD staff, Erik Gurshaw, conducted an unannounced, self-initiated inspection at Motovicity Distribution located at 32655 Industrial Dr. in Madison Heights, Michigan. The purpose of the inspection was to determine compliance with the Federal Clean Air Act; Article II, Part 55, Air Pollution Control of Natural Resources and Environmental Protection Act, 1994 Public Act 451; and Michigan Department of Environmental Quality, Air Quality Division (MDEQ-AQD) Rules.

Upon arriving at the facility, AQD staff introduced themselves and stated the purpose of the visit to Mr. Mike Smith, Facilities Manager. Mr. Smith indicated that Motovicity Distribution employs approximately 70 people and is open Monday through Friday from 8:00 AM until 5:00 PM. Mr. Smith assisted AQD staff during the inspection.

Motovicity Distribution is a distributor of after-market performance automotive parts. The company buys parts, sells them, and ships them to their customers. Some of the parts bought and sold by the company include the following: engine internals; chargers/superchargers; air-intake valves; throttle bodies; etc. The company also sells racing gear such as racing suits, racing helmets, racing gloves, and racing seats. The building consists of approximately 8,000 square feet of office space and 27,000 square feet of warehouse space.

The only process or process equipment at the company which would result in air emissions is a 25 kW natural gas fired Guardian Model #0047260 emergency generator. This generator was installed in 2003 and is a 25 kVa, 60 Hertz generator with a serial number of 3813338. The emergency generator is subject to MACT Subpart ZZZZ for reciprocating internal combustion engines (RICE), but the AQD has not accepted delegation for RICE engines subject to this Subpart at area sources of hazardous air pollutant (HAP) emissions.

Based on this inspection, it was determined that Motovicity Distribution has an emergency RICE engine subject to MACT Subpart ZZZZ, but the AQD has not accepted delegation for RICE engines subject to this Subpart at area sources of HAP emissions.
