On April 9, 2015, I, Rebecca Loftus, from the Department of Environmental Quality's (DEQ), Air Quality Division (AQD), conducted a self-initiated inspection of the building located at 31625 Grand River, in Farmington, Michigan. The inspection was prompted as part of an effort to clean up AQD files. The purpose of this inspection was to determine the facility's compliance with the Federal Clean Air Act Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act of 1994, PA 451, as amended, and Michigan's Air Pollution Control Rules.

According to the file, Bob Dusseau Inc., previously occupied the building at this location. In 1998, the AQD received correspondence from Bob Dusseau Inc stating that the facility did not use Halogenated Solvents in their cold cleaners and they are not subject to 40 CFR, Part 63, Subpart T.

I arrived on-site at 12:45pm and spoke with Ms. Sharon Hudson. Danboise Mechanical Inc. (DMI) now occupies the building. DMI provides heating and cooling services to commercial and industrial businesses. Ms. Hudson escorted me through the building and I observed the following: Most of the building is currently used as storage and office space. In the back of the building, there are machines used to customize sheet metal for each heating/cooling job. The machines included equipment used for bending and cutting as well as plasma cutting/welding. This equipment was not in use during my inspection. All of the equipment appears to be exempt from obtaining an air permit to install pursuant to Rules 285(i), 285(l)(i), and 285(l)(vi).

Based on the information gathered, Bob Dusseau is no longer in business at this location and no solvent cleaning equipment was observed on-site. At this time, DMI appears to be in compliance with the Federal Clean Air Act Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act of 1994, PA 451, as amended, and Michigan's Air Pollution Control Rules.
