## **VIOLATION NOTICE**

On February 17, 2021, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD), conducted an inspection of the two (2) adjacent, vacant residential properties located at 444 and 424 N. Rochester Road, Clawson. The purpose of this inspection was to determine compliance with the requirements of Title 40 of the Code of Federal Regulations (CFR), Part 61, National Emission Standards for Hazardous Air Pollutants (NESHAP), Subpart M and Rule 942 of the administrative rules promulgated under Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, Trowbridge Land Holdings LLC owns the facilities and F&M Construction, Inc. performed the demolition activities at the properties. The NESHAP for Asbestos holds both the owner and operator equally liable for violations.

During the inspection, staff observed the following: A vacant commercial property undergoing subgrade retrofitting. Records indicate that two (2) single family residences were demolished as part of this project to build a thirty (30) unit apartment building. A 10-day notification of intent was not submitted prior to demolition of the structures. A copy of the asbestos surveys for the structures was requested, but not provided. The owner of the properties was made aware of the NESHAP survey and 10-day notification requirements by EGLE staff in an email dated July 24, 2020. Demolitions occurred in December of 2020.

Please initiate actions necessary to correct the cited violations and submit a signed written response to this Violation Notice by April 9, 2021 (which coincides with 21 calendar days from the date of this letter). The response should include: the dates the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence. If thorough asbestos surveys and/or abatement activities were conducted at these properties, please provide collaborating documentation in your response.
