VIOLATION NOTICE

On February 23, 2024, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD) conducted an inspection at the properties located at 436 14 Mile Road; 446 14 Mile Road; and 456 14 Mile Road, Clawson, Oakland County. The purpose of this inspection was to determine compliance with the requirements of Title 40 of the Code of Federal Regulations (40 CFR), Part 61, Subpart M (National Emission Standard for Asbestos), and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, Trowbridge Companies, LLC owns the property, and R and B Companies, LLC conducted the demolition activities. The National Emission Standard for Asbestos holds both the owner and operator equally liable for violations.

During the inspection, AQD staff noted a subject residential installation of three (3) adjacent, single-family residential structures that had been demolished for one project. No Notification of Intent to Demolish had been filed. Documentation verifying asbestos survey and abatement activities at the site was provided.

- A summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place;

- Acknowledgement of receipt, and understanding of, the attached "Understanding NESHAP" fact sheet.

The signed written response from the owner and operator to this violation notice may be submitted by mail and directed to the attention of Jeremy Howe, Supervisor, Technical Programs Unit at EGLE, AQD, P.O. Box 30260, Lansing, Michigan 48909-7760 and must include a copy to Jason Wolf, Enforcement Unit at the same address. If the listed parties believe the above observations or statements are inaccurate or do not constitute a violation of the applicable legal requirements cited, please provide appropriate factual information to explain your position.
