VIOLATION NOTICE

On March 14, 2019, the Department of Environmental Quality (DEQ), Air Quality Division (AQD) performed an asbestos inspection located at 409 West Main Street, Owosso, Shiawassee County Michigan. The purpose of this inspection was to determine compliance with the requirements of Title 40 of the Code of Federal Regulations, Part 61, Subpart M (National Emission Standard for Asbestos), and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451).

According to our investigation, Fisher Gravel was the operator who conducted the demolition activities, and Mr. Bob Nelson is the property owner of the address mentioned above. The National Emission Standard for Asbestos holds the <u>owner and operator</u> liable for all violations.

During the investigation staff observed the following:

I inspected the site and the structure was demolished and the debris was removed. After searching the DEQ Asbestos Notification System (ANS), I found no record of a notification being submitted 10 working days prior to demolition starting. I did obtain a copy of the demolition permit from the City, which included the asbestos survey, notification of the asbestos abatement work and the manifest from the disposal.

Please initiate actions necessary to correct the cited violations and submit a written response to this violation notice by April 12, 2019, (which coincides with 21 calendar days from the date of this letter). The written response should include: the date(s) the violations

occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations, and the date(s) by which these actions will take place; and what steps are being taken to prevent a reoccurrence. The <u>signed</u> written response from the <u>owner and operator</u> to this violation notice, may be submitted by mail and directed to my attention at: DEQ AQD, P.O. If you believe the above observations or statements are inaccurate or do not constitute a violation of the applicable legal requirements cited, please provide appropriate factual information to explain your position.
