## SECOND VIOLATION NOTICE

On April 1, April 9 and September 20, 2021, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD), conducted an inspection of the apartment building located at 9429 Main St., Whitmore Lake, MI. The purpose of this inspection was to determine the owner's and operator's compliance with the requirements of Title 40 of the Code of Federal Regulations (CFR), Part 61, National Emission Standards for Hazardous Air Pollutants (NESHAP), Subpart M and Rule 942 of the administrative rules promulgated under Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

On October 7, 2021, the AQD sent you a Violation Notice citing violations discovered as a result of the inspections and requested your written response by November 12, 2021. A copy of that letter is enclosed for your reference.

As of this date, we have only received a partial e-mail response to the Violation Notice. The response should include: the dates the violation occurred; the dates by which actions will be taken to correct the violation (an asbestos survey performed by a licensed asbestos building inspector and asbestos clean-up activities by a licensed asbestos contractor); and what steps are being taken to prevent a reoccurrence of the violation. As part of your response, please provide a copy of the asbestos survey for the property, as well as waste ship records for asbestos clean-up activities.

Please be advised that failure to respond in writing and identifying actions you will take or has taken to resolve the cited violation may result in escalated enforcement action by the AQD. Please provide the information requested in our October 7, 2021, letter by December 3, 2021, which corresponds to 14 days from the date of this letter.
