## VIOLATION NOTICE

On May 29, 2018, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of residential property located at 20521 Fayette, Detroit. The purpose of this inspection was to determine compliance with the requirements of Title 40 of the Code of Federal Regulations, Part 61, National Emission Standards for Hazardous Air Pollutants (NESHAP), Subpart M, and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, the Detroit Land Bank Authority owns the residential property. The Gayanga Co., LLC demolished the residential structure for the City of Detroit. The Detroit Building Authority manages the City of Detroit's demolition program. The NESHAP for Asbestos holds the owner and operators liable for violations.

On Friday, May 25, 2018, the Detroit Building Authority contacted the DEQ to inform them that the house located at 20521 Fayette, Detroit had been mistakenly demolished by Gayanga Co. LLC.

The written response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If the Detroit Land Bank Authority, the Detroit Building Authority, the City of Detroit Office of Contracting and Procurement and/or Gayanga Co., LLC believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.

Thank you for your attention to resolving the violation cited above and for the cooperation that was extended to me during my inspection of 20521 Fayette, Detroit.
