VIOLATION NOTICE

On June 6 and 13th, 2018, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of commercial property located at 21840 Eureka, Taylor. The purpose of this inspection was to determine 21840 Eureka, LLC's and DA Contracting, LLC's compliance with the requirements of Title 40 of the Code of Federal Regulations, Part 61, National Emission Standards for Hazardous Air Pollutants (NESHAP), Subpart M and Rule 942 of the administrative rules promulgated under Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, 21840 Eureka, LLC owns the facility and DA Contracting, LLC performed the renovation and demolition activities at the facility. The NESHAP for Asbestos holds the owner and operator liable for violations.

During the inspection, DEQ staff observed that the interior and exterior of the building was undergoing renovation. A portion of the building had also been demolished. A copy of the asbestos survey was requested but not provided. Suspect asbestos containing materials were sampled; results are pending.

Please note that if an asbestos survey conducted by a licensed asbestos inspector of the structure was not obtained prior to the initiation of renovation/demolition activities, or samples collected at the site test positive for asbestos, one or more of the following violations may have also occurred:

Please initiate actions necessary to correct the cited violations and submit a signed written response to this Violation Notice by July 6, 2018 (which coincides with 21 calendar days from the date of this letter). The response should include:

- The dates the violations occurred;
- An explanation of the causes and duration of the violations;
- Whether the violations are ongoing;
- A summary of the actions that have been taken and are proposed to be taken to correct the violations and the dates by which these actions will take place;
- What steps are being taken to prevent a reoccurrence; and
- A copy of the asbestos survey for the building.
