**This letter supersedes the letter dated May 17, 2019, which incorrectly identified the property as 15972 Holmur, Detroit**

**VIOLATION NOTICE**

On April 10 and 19, 2019, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD), conducted an inspection of the residential property located at 15792 Holmur, Detroit. The purpose of this inspection was to determine compliance with the requirements of Title 40 of the Code of Federal Regulations (CFR), Part 61, National Emission Standards for Hazardous Air Pollutants (NESHAP), Subpart M and Rule 942 of the administrative rules promulgated under Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, the Detroit Land Bank Authority owns the property and Go Green Contracting, Inc. performed the asbestos abatement activities at the facility. The NESHAP for Asbestos holds both the owner and operator liable for violations.

During the inspection, AQD staff observed the house was cleared for demolition. However, paper backing was found on the kitchen floor which tested positive for asbestos.

Please initiate actions necessary to correct the cited violation and submit a signed written response to this Violation Notice by June 24, 2019 (which coincides with 21 calendar days from the date of this letter). The response should include: the dates the violation occurred; an explanation of the causes and duration of the violation, whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.


