ATTACHMENT G: EXAMPLE PUBLIC HEARING NOTICE

This attachment is an *example* of a public notice used for a permit that required public comment. The time, date and location of all hearings is determined by the AQD based on the availability of the decision maker and facilities in which to hold the hearing.

EXAMPLE

NOTICE OF AIR POLLUTION COMMENT PERIOD AND PUBLIC HEARING

The Michigan Department of Environmental Quality is holding a public comment period until January 7, 1999, and a public hearing, if requested, on January 12, 1999 to afford all interested citizens the opportunity to comment on the Department staff's proposed conditional approval of a Permit to Install application submitted by ANR PIPELINE COMPANY for installation and operation of compressor, proposed for location at 3372 Browntown Road, Bridgman, Michigan. It has been preliminarily determined that the turbine will not violate any of the Department's rules nor the National Ambient Air Quality Standards and will not consume more than 15 percent, 0 percent, and 1 percent of the federal Prevention of Significant Deterioration Air Quality Increments for particulate, sulfur dioxide, and nitrogen dioxide respectively. Furthermore, the total increment consumed for all sources in the area is 15 percent, 0 percent, and 1 percent, leaving 85 percent, 100 percent, and 99 percent for particulate, sulfur dioxide and nitrogen dioxide, respectively, at the maximum point of impact.

This proposal is subject to the federal Prevention of Significant Deterioration rules and regulations for particulate matter less than 10 microns, nitrogen oxides, carbon monoxide and volatile organic compounds.
