Dear Mr. Ragalyi:

This letter is in reference to your Permit to Install (PTI) application, identified as No. 13-19B, State Registration Number B2767. The application was received on September 2, 2020, for proposed changes to a previously permitted project involving a new automotive paint shop and changes to the existing automotive assembly line at the Warren Truck Assembly Plant located at 21500 Mound Road in Warren, Michigan.

Review of your PTI application is complete. We have announced a public comment period as required by state and federal regulations, on the intent of the Michigan Department of Environment, Great Lakes, and Energy (EGLE) to approve the proposed permit. The public comment period will begin on April 28, 2021 and will end on June 14, 2021. An informational session and public hearing have been scheduled on June 2, 2021; however, they will be held only if requested by May 28, 2021. You may submit comments during the comment period and are encouraged to appear at the informational session and public hearing, if held, on behalf of your PTI application.

After resolving any issues raised during the public comment period and/or the hearing, a final decision will be made on your PTI application.

By law, construction of the proposed process should not begin until you receive an approved PTI. *This letter is not an approved permit to install* and only references a proposed action on your PTI application.

Enclosed are copies of the proposed permit conditions, "Notice of Air Pollution Comment Period and Public Hearing," "Proposed Project Summary," and the "Technical Fact Sheet" regarding our analysis of your proposed project.

If you have any questions, please feel free to contact me. You may call me on June 1, 2021, to determine if a hearing was requested.
