Dear Mr. Minner:

This letter is in reference to your Permit to Install (PTI) application, identified as No. 33-20. The application was received on March 18, 2020, for a proposed automotive coating line, natural gas equipment, and relocating rapid repair operations, at your existing facility located at 2101 Conner Avenue, Detroit, Michigan, State Registration Number N2155.

Review of your PTI application is complete. We have announced a second public comment period, as required by state and federal regulations, on the intent of the Michigan Department of Environment, Great Lakes, and Energy (EGLE) to approve the proposed permit. The second public comment period is necessary because FCA proposed changes to the application. Changes made to the draft permit are:

- 1. The addition of updated conditions for four existing emission units;
- 2. Additional recordkeeping and reporting requirements; and
- 3. To allow 12 months after installation for the average amount of VOC emissions per job to decrease from the current 4.8 pounds per job (vehicle) to 4.4 pounds per job.

The public comment period will begin on February 10, 2021 and will end on March 22, 2021. An informational session and public hearing have been scheduled for March 16, 2021. You may submit comments during the comment period and are encouraged to appear at the virtual informational session and public hearing on behalf of your PTI application.

After resolving any issues raised during the public comment period and hearing, a final decision will be made on your PTI application.

By law, construction of the proposed process should not begin until you receive an approved PTI. *This letter is not an approved permit to install* and only references a proposed action on your PTI application.
