

NOTICE of AIR POLLUTION COMMENT PERIOD and PUBLIC HEARING

The Michigan Department of Environment, Great Lakes, and Energy (EGLE) is holding a public comment period from February 14, 2020 until March 18, 2020, and a public hearing on March 18, 2020, for two Permit to Install (PTI) applications from Eagle Mine, a subsidiary of Lundin Mining. PTI application No. 50-06D is for proposed changes to the surface operations and the timeframe of the ore truck throughput limit at the underground nickel and copper mine (Eagle Mine) located at 6510 AAA Road, Michigamme Township, Michigan. PTI application No. 405-08B is for a proposed change to the timeframe of the ore truck throughput limit at the nickel and copper ore processing mill (Humboldt Mill) located at 4547 County Road 601, Champion, Michigan. The public comment period and public hearing are to allow all interested parties the opportunity to comment on the proposed conditional approval of the PTIs. It has been preliminarily determined that the permit modifications will not violate any of EGLE's rules nor the National Ambient Air Quality Standards. The Eagle Mine's impact will not exceed the available increments for particulate matter less than ten microns and particulate matter less than 2.5 microns.



All statements received by March 18, 2020 will be considered by the decision-maker prior to final permit action.

An informational session and public hearing will be held on March 18, 2020 at the Westwood High School Auditorium, 200 Westwood Drive, Ishpeming, Michigan. The informational session will begin at 5:30 p.m., at which time AQD staff will be available to answer questions about the proposed permits. The public hearing will begin at 7:00 p.m. The sole purpose of the public hearing will be to take formal testimony about the proposed permits on the record.
