This letter is in reference to your Permit to Install (PTI) application, identified as No. APP 2021-0019, for a new hot mix asphalt plant proposed to be located at 5088 Energy Drive, Flint, Michigan (State Registration Number P1171).

The public comment period ended on September 22, 2021, and virtual public hearings were held on August 3 and September 1, 2021. Comments were received during the comment period and at the virtual public hearings.

After careful consideration of the issues and pursuant to the delegation of authority from the Director of the Michigan Department of Environment, Great Lakes, and Energy (EGLE), I have approved PTI No. 90-21. As a part of this approval, Air Quality Division (AQD) staff has revised and added conditions to the permit to address certain information received during the public participation process and the subsequent analysis of that information.

The AQD has prepared the enclosed Response to Comments (RTC) Document, which provides our responses to comments received during the public comment period and at the virtual public hearings. It also identifies the special conditions that have been modified and provides our rationale for modifying the proposed special conditions. These changes are listed in Section II of the RTC Document.

This approval is based upon and subject to compliance with all administrative rules of EGLE and conditions stipulated in the enclosed supplement. Please review these conditions thoroughly so that you may take the actions necessary to ensure compliance with all of these conditions.
