NOTICE of AIR PERMIT COMMENT PERIOD and PUBLIC HEARING

The Michigan Department of Environment, Great Lakes, and Energy (EGLE) is holding a public comment period and virtual public hearing to allow the public the opportunity to comment on the proposed conditional approval of an air permit.

There is a public comment period from July 1, 2021, until August 16, 2021, and a virtual public hearing on August 3, 2021 for:

Company: Ajax Materials Corporation (Ajax) proposed to locate at 5088 Energy Drive, Flint, Michigan

What Ajax wants to do:

Under application No. APP-2021-0019, Ajax is requesting to install and operate a new hot mix asphalt (HMA) plant.

The public comment period and public hearing are to allow all interested parties the opportunity to comment on the proposed conditional approval of a Permit to Install (PTI). It has been preliminarily determined that the installation of new equipment will not violate any of EGLE's rules nor the National Ambient Air Quality Standards. The facility's impact will also not exceed the available increments for sulfur dioxide, nitrogen oxides, particulate matter less than or equal to 10 microns in diameter, and particulate matter less than or equal to 2.5 microns in diameter.
