Dear Phillip Oliver:

This letter is in reference to your Permit to Install (PTI) application, identified as No. APP-2022-0276, to install secondary chamber afterburners on two burn-off ovens, to update the parameters for the e-coat oven stacks, and for a nuisance minimization plan for odors located at 6070 Eighteen Mile Road in Sterling Heights, Michigan (State Registration Number N5145).

The public comment period ended on April 28, 2023. A request for a public hearing was not received during the comment period. One written comment was received.

After careful consideration of the issues and pursuant to the delegation of authority from the Director of the Michigan Department of Environment, Great Lakes, and Energy (EGLE), I have approved PTI No. 25-16A with one modification made to the proposed permit.

The following comment was submitted during the public comment period:

COMMENT:

There is an incorrect emission unit name in special condition III.2 of FGOVENS. The permit conditions referred to an "EUBURNOFF" however, the requirements of the condition apply to FGOVENS.

AQD RESPONSE:

The reference to EUBURNOFF in Special Condition No. III.2 of FGOVENS was removed and replaced with FGOVENS.

This approval is based upon and subject to compliance with all administrative rules of EGLE and conditions stipulated in the enclosed supplement. Please review these conditions thoroughly so that you may take the actions necessary to ensure compliance with all of these conditions.

Also, PTI No. 25-16 has been voided because the equipment is now covered by PTI No. 25-16A.
