Dear Interested Party:

Thank you for your interest regarding the Permit to Install (PTI) Application No. APP-2022-0276 submitted by Industrial Metal Coating, to the Michigan Department of Environment, Great Lakes, and Energy (EGLE), requesting to install secondary chamber afterburners on two burn-off ovens, to update the parameters for the e-coat oven stacks, and for a nuisance minimization plan for odors, for the facility located at 6070 Eighteen Mile Road in Sterling Heights, Michigan.

Pursuant to state and federal requirements, EGLE held a public comment period that ended on April 28, 2023. The Air Quality Division (AQD) received one written comment during the public comment period.

After careful consideration of the issues and pursuant to the delegation of authority from the Director of EGLE, I have approved PTI No. 25-16A with one modification made to the proposed permit.

The following comment was submitted during the public comment period:

COMMENT:

There is an incorrect emission unit name in special condition III.2 of FGOVENS. The permit conditions referred to an "EUBURNOFF" however, the requirements of the condition apply to FGOVENS.

AQD RESPONSE:

The reference to EUBURNOFF in Special Condition No. III.2 of FGOVENS was removed and replaced with FGOVENS.
