This letter is in reference to your Permit to Install (PTI) application, identified as No. APP-2023-0025, for installation of a new utility flare located at 9536 East Lennon Road, in Lennon, Michigan (State Registration Number N5910).

The public comment period ended on November 6, 2023. No comments were received nor was a request for a public hearing made during this period. Pursuant to the delegation of authority from the Director of the Michigan Department of Environment, Great Lakes, and Energy (EGLE), I have approved PTI No. 130-23.

This approval is based upon and subject to compliance with all administrative rules of EGLE and conditions stipulated in the enclosed supplement. Please review these conditions thoroughly so that you may take the actions necessary to ensure compliance with all these conditions.

The equipment covered by this permit is also subject to the requirements of the Renewable Operating Permit (ROP) Program. Submittal of the M-001 and C-001 forms may be required prior to commencing operation. A change that is subject to Rule 215 subrules (1), (2), or (3), promulgated pursuant to Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended, requires the submittal of the forms to the appropriate Air Quality Division (AQD) District Office. If a change is made pursuant to Rule 216, please submit the required forms to the Grand Rapids District Office at the address provided in the M-001 form instructions. Also, you must notify the Lansing District Office, in writing, within 30 days after completion of the installation, construction, reconstruction, relocation, or modification of the process or process equipment covered by this PTI.
