NOTICE of AIR PERMIT COMMENT PERIOD

The Michigan Department of Environment, Great Lakes, and Energy (EGLE) is holding a public comment period and a virtual public hearing, if requested, to allow the public the opportunity to comment on the proposed conditional approval of an air permit.

There is a public comment period from September 20, until November 6, 2023, and a virtual public hearing, if requested, on October 24:

Company: Venice Park Recycling and Disposal Facility (RDF) located at 9536 Lennon Road, Lennon, Michigan

What the company wants to do: Application No. APP-2023-0025 is for the installation and operation of a new utility flare.



Technical Details: The facility's impact will not exceed the available increments for sulfur dioxide, nitrogen oxides, particulate matter less than or equal to ten microns in diameter, and particulate matter less than or equal to 2.5 microns in diameter.

Additionally, the installation of new equipment will require revisions to Renewable Operating Permit (ROP) No. MI-ROP-N5910-2022 (SRN N5910). This public comment period meets the public participation requirements for a future administrative amendment to the ROP.

The public comment period is to allow all interested parties the opportunity to comment on the proposed conditional approval of a Permit to Install (PTI). It has been preliminarily determined that the installation of the new equipment will not violate any of EGLE's rules nor the National Ambient Air Quality Standards.
