This letter is in reference to your Permit to Install (PTI) application, identified as No. APP-2023-0141, for installation of a packed-bed scrubber to control odors from the spray dryer used to manufacture powdered eggs at 1336 East Maumee Street in Adrian, Michigan (State Registration Number E8117).

The public comment period ended on January 8, 2024, and a public hearing was held on December 6, 2023. Comments were received during the comment period and at the public hearing. After careful consideration of the issues and pursuant to the delegation of authority from the Director of the Michigan Department of Environment, Great Lakes, and Energy (EGLE), I have approved PTI No. 38-06A. As a part of this approval, Air Quality Division (AQD) staff has revised the permit conditions to reflect that the scrubber has been installed.

This approval is based upon and subject to compliance with all administrative rules of EGLE and conditions stipulated in the enclosed supplement. Please review these conditions thoroughly so that you may take the actions necessary to ensure compliance with all of these conditions.

Also, PTI No. 38-06 will be voided because the equipment is now covered by PTI No. 38-06A.
