Dear Interested Party:

We are sending you this information because you may have an interest in air quality related activities associated with Crimson Holdings, LLC located at 1336 East Maumee Street in Adrian, Michigan. There are two air quality actions being proposed.

1. The company has submitted an air permit application (No. [APP-2023-0141](#)) for the proposed installation of an air pollution control device called a packed bed scrubber. The equipment is intended to reduce odors from the spray dryer used to manufacture powdered eggs.
2. The company is also proposing to enter into an enforcement action called a consent order. The consent order would require a plan to return to compliance, pay a monetary penalty, and have additional fines if violations continue. If approved, the consent order would resolve an alleged violation of the federal Clean Air Act.

The law requires the Michigan Department of Environment, Great Lakes, and Energy (EGLE) to open some actions for the public to comment on, including the proposed air permit and the proposed consent order. Public comments are a very important part of making sure both proposals have been thoroughly reviewed.


