NOTICE of COMMENT PERIOD and PUBLIC HEARING

The Michigan Department of Environment, Great Lakes, and Energy (EGLE) is holding a public comment period and a virtual public hearing to allow the public the opportunity to comment on the proposed conditional approval of an air permit and a proposed consent order.

There is a public comment period from November 6, 2023, until January 8, 2024, and a virtual public hearing on December 6, 2023, for:

Company: Crimson Holdings, LLC located at 1336 East Maumee Street in Adrian, Michigan

What is open for comment? Two air quality actions related to the company are open for comment:



- Air permit application No. <u>APP-2023-0141</u> for the proposed installation of an air pollution control device called a packed bed scrubber. This equipment is intended to reduce odors from the existing spray dryer used to manufacture powdered eggs.
- Proposed enforcement action called a consent order. The proposed consent order requires a plan to return
 to compliance, a monetary penalty, and additional fines for any future violations. If approved, the consent
 order would resolve alleged violations of the federal Clean Air Act.

Technical Details: The public comment period and public hearing are to allow all interested parties the opportunity to comment on the proposed conditional approval of a Permit to Install (PTI) and consent order.

It has been preliminarily determined that the spray dryer with the scrubber will not violate any of EGLE's rules nor the National Ambient Air Quality Standards. The facility's impact will not exceed the significant impact levels for particulate matter less than or equal to ten microns in diameter and particulate matter less than or equal to 2.5 microns in diameter.
