Dear Interested Party:

Thank you for your interest regarding the Permit to Install (PTI) application submitted by Universal Coating, Inc, to the Michigan Department of Environment, Great Lakes, and Energy (EGLE). The application is identified as No. APP-2023-0147 and requested the installation and operation of two new tumble spray coating lines at the facility, located at 5304 Energy Drive in Flint, Michigan.

Pursuant to state and federal requirements, EGLE held a public comment period that ended on February 15, 2024, on its proposed conditional approval of the air permit. An informational session and public hearing was held on February 8, 2024. The Air Quality Division (AQD) received seven written comments during the public comment period and eight verbal comments were presented at the public hearing.

After careful consideration of the issues and pursuant to the delegation of authority from the Director of EGLE, I have approved PTI No. 28-24 with modifications made to the proposed permit.

The Response to Comments (RTC) Document provides our responses to comments received during the public comment period and at the public hearing. It also identifies special conditions which have been modified and provides our rationale for modifying the proposed special conditions. The changes are listed in Section II of the RTC Document. The RTC Document and the Permit Terms and Conditions are available at: Michigan.gov/EGLEAirPublicNotice, choose "Final Decisions."

Changes made to the permit include:

- The reduction of the VOC, acetone (CAS No. 67-64-1), and methyl acetate (CAS No. 79-20-9), combined limit from 49.7 tpy to 48.0 tpy.
- Additional language to Special Condition IV.4, to specify that a device must be maintained to measure either the velocity or pressure drop across the Permanent Total Enclosure of FG-RTO.
