Dear Jeff Kirby:

This letter is in reference to your Permit to Install (PTI) application, identified as No. APP-2023-0168, State Registration Number B1772. The application was received on July 6, 2023, for modifications to the exhaust stack parameters for the existing fiberglass composite pole manufacturing process located at 151 Lafayette Street in Mt. Clemens, Michigan.

Review of your PTI application is complete. We have announced a public comment period as required by state and federal regulations, on the intent of the Michigan Department of Environment, Great Lakes, and Energy (EGLE) to approve the proposed permit. The public comment period will begin on September 6, 2023, and will end on October 21, 2023. A virtual informational session and public hearing have been scheduled on October 10, 2023; however, they will be held only if requested by October 2, 2023. You may submit comments during the comment period and are encouraged to appear at the informational session and public hearing, if held, on behalf of your PTI application.

After resolving any issues raised during the public comment period and/or the virtual hearing, if held, a final decision will be made on your PTI application.

By law, construction of the proposed process should not begin until you receive an approved PTI. *This letter is not an approved permit to install* and only references a proposed action on your PTI application.

Enclosed are copies of the proposed permit conditions, "Notice of Air Pollution Comment Period," "Proposed Project Summary," and the "Technical Fact Sheet" regarding our analysis of your proposed project.

If you have any questions, please feel free to contact me. You may call me on October 3, 2023, to determine if a hearing was requested.
