This letter is in reference to your Permit to Install (PTI) application, identified as No. APP-2023-0259, for installation of secondary chamber afterburners on two existing burn-off ovens located at 6070 Eighteen Mile Road in Sterling Heights, Michigan (State Registration Number N5145).

The public comment period ended on March 13, 2024. No comments were received nor was a request for a public hearing made during this period. Pursuant to the delegation of authority from the Director of the Michigan Department of Environment, Great Lakes, and Energy (EGLE), I have approved PTI No. 25-16B.
