## Dear Adam Brentlinger:

This letter is in reference to your Permit to Install (PTI) application, No. APP-2023-0033, State Registration Number N6631. The application was received on January 30, 2023, for incorporating requirements from the Sulfur Dioxide Federal Implementation Plan into a PTI for existing Boilers 1, 2, 3, and existing Flares 1 and 2 located at 2400 Miller Road in Dearborn, Michigan.

The public comment period ended on August 28, 2023. No comments were received nor was a request for a public hearing made during this period. Pursuant to the delegation of authority from the Director of the Michigan Department of Environment, Great Lakes, and Energy (EGLE), I have approved PTI No. 109-23.

The equipment covered by this permit is also subject to the requirements of the Renewable Operating Permit (ROP) Program. Submittal of the M-001 and C-001 forms may be required prior to commencing operation. A change that is subject to Rule 215 subrules (1), (2), or (3), promulgated pursuant to Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended, requires the submittal of the forms to the appropriate AQD District Office. If a change is made pursuant to Rule 216, please submit the required forms to the Grand Rapids District Office at the address provided in the M-001 form instructions.
