Dear Marion Krchmar:

This letter is in reference to your Permit to Install (PTI) application, identified as No. APP-2022-0290, State Registration Number A7809. The application was received on November 9, 2022, for incorporating requirements from the Sulfur Dioxide (SO₂) Federal Implementation Plan (FIP) into a PTI for existing Boilerhouse No. 2 located at 1300 Zug Island Road in River Rouge, Michigan.

Review of your PTI application is complete. We have announced a public comment period as required by state and federal regulations, on the intent of the Michigan Department of Environment, Great Lakes, and Energy (EGLE) to approve the proposed permit. The public comment period will begin on July 12, 2023 and will end on August 28, 2023. A virtual informational session and public hearing have been scheduled on August 15, 2023; however, they will be held only if requested by August 7, 2023. You may submit comments during the comment period and are encouraged to appear at the virtual informational session and public hearing, if held, on behalf of your PTI application.

After resolving any issues raised during the public comment period and/or the virtual hearing, if held, a final decision will be made on your PTI application.

Enclosed are copies of the proposed permit conditions, "Notice of Air Permit Comment Period," and the "Technical Fact Sheet" regarding our analysis of your application.
