## NOTICE of AIR PERMIT COMMENT PERIOD

The Michigan Department of Environment, Great Lakes, and Energy (EGLE) is holding a public comment period and a virtual public hearing, if requested, to allow the public the opportunity to comment on the proposed conditional approval of three air permits.

# Comment period from July 12, 2023, until August 28, 2023, and a virtual public hearing, if requested, on August 15, 2023 for:

**Companies:** EES Coke Battery, Dearborn Industrial Generation, LLC (DIG), and US Steel

**What is the permitting action:** The purpose of these permitting actions is to add the sulfur dioxide (SO<sub>2</sub>) emission limits from the USEPA Federal Implementation Plan (FIP or Federal Plan) into the appropriate air permits.



The permit modifications require revisions to the Renewable Operating Permit (ROP) for each facility: EES Coke and US Steel (<u>A7809, ROP No. 199600132d</u>) and DIG (<u>N6631, ROP No. MI-ROP-N6631-2012a</u>). This public comment period meets the public participation requirements for future administrative amendments to the ROPs.
