GENERAL CONDITIONS

- 1. The process or process equipment covered by this permit shall not be reconstructed, relocated, or modified, unless a Permit to Install authorizing such action is issued by the Department, except to the extent such action is exempt from the Permit to Install requirements by any applicable rule. (R 336.1201(1))
- 2. If the installation, construction, reconstruction, relocation, or modification of the equipment for which this permit has been approved has not commenced within 18 months, or has been interrupted for 18 months, this permit shall become void unless otherwise authorized by the Department. Furthermore, the permittee or the designated authorized agent shall notify the Department via the Supervisor, Permit Section, Air Quality Division, Michigan Department of Environment, Great Lakes, and Energy, P.O. Box 30260, Lansing, Michigan 48909-7760, if it is decided not to pursue the installation, construction, reconstruction, relocation, or modification of the equipment allowed by this Permit to Install. (R 336.1201(4))
- 3. If this Permit to Install is issued for a process or process equipment located at a stationary source that is not subject to the Renewable Operating Permit program requirements pursuant to Rule 210 (R 336.1210), operation of the process or process equipment is allowed by this permit if the equipment performs in accordance with the terms and conditions of this Permit to Install. (R 336.1201(6)(b))
- 4. The Department may, after notice and opportunity for a hearing, revoke this Permit to Install if evidence indicates the process or process equipment is not performing in accordance with the terms and conditions of this permit or is violating the Department's rules or the Clean Air Act. (R 336.1201(8), Section 5510 of Act 451, PA 1994)
- 5. The terms and conditions of this Permit to Install shall apply to any person or legal entity that now or hereafter owns or operates the process or process equipment at the location authorized by this Permit to Install. If the new owner or operator submits a written request to the Department pursuant to Rule 219 and the Department approves the request, this permit will be amended to reflect the change of ownership or operational control. The request must include all of the information required by subrules (1)(a), (b), and (c) of Rule 219 and shall be sent to the District Supervisor, Air Quality Division, Michigan Department of Environment, Great Lakes, and Energy. (R 336.1219)
- 6. Operation of this equipment shall not result in the emission of an air contaminant which causes injurious effects to human health or safety, animal life, plant life of significant economic value, or property, or which causes unreasonable interference with the comfortable enjoyment of life and property. (R 336.1901)
- 7. The permittee shall provide notice of an abnormal condition, start-up, shutdown, or malfunction that results in emissions of a hazardous or toxic air pollutant which continue for more than one hour in excess of any applicable standard or limitation, or emissions of any air contaminant continuing for more than two hours in excess of an applicable standard or limitation, as required in Rule 912, to the Department. The notice shall be provided not later than two business days after start-up, shutdown, or discovery of the abnormal condition or malfunction. Written reports, if required, must be filed with the Department within 10 days after the start-up or shutdown occurred, within 10 days after the abnormal condition or malfunction has been corrected, or within 30 days of discovery of the abnormal condition or malfunction, whichever is first. The written reports shall include all of the information required in Rule 912(5). (R 336.1912)
- 8. Approval of this permit does not exempt the permittee from complying with any future applicable requirements which may be promulgated under Part 55 of 1994 PA 451, as amended or the Federal Clean Air Act.
- 9. Approval of this permit does not obviate the necessity of obtaining such permits or approvals from other units of government as required by law.
- 10. Operation of this equipment may be subject to other requirements of Part 55 of 1994 PA 451, as amended and the rules promulgated thereunder.

- 11. Except as provided in subrules (2) and (3) or unless the special conditions of the Permit to Install include an alternate opacity limit established pursuant to subrule (4) of Rule 301, the permittee shall not cause or permit to be discharged into the outer air from a process or process equipment a visible emission of density greater than the most stringent of the following. The grading of visible emissions shall be determined in accordance with Rule 303 (R 336.1303). (R 336.1301)
 - a) A six-minute average of 20 percent opacity, except for one six-minute average per hour of not more than 27 percent opacity.
 - b) A visible emission limit specified by an applicable federal new source performance standard.
 - c) A visible emission limit specified as a condition of this Permit to Install.
- 12. Collected air contaminants shall be removed as necessary to maintain the equipment at the required operating efficiency. The collection and disposal of air contaminants shall be performed in a manner so as to minimize the introduction of contaminants to the outer air. Transport of collected air contaminants in Priority I and II areas requires the use of material handling methods specified in Rule 370(2). (R 336.1370)
- 13. The Department may require the permittee to conduct acceptable performance tests, at the permittee's expense, in accordance with Rule 1001 and Rule 1003, under any of the conditions listed in Rule 1001. (R 336.2001)

2. The permittee shall not exceed a monthly production weighted average emission factor of 7.38 or more pounds of VOC per ton of buns produced in EU002. (R 336.1205(1)(a), R336.1702(a))

III. PROCESS/OPERATIONAL RESTRICTION(S)

 Catalytic Oxidizer Bypass Episode: the permittee may operate EU003 without the catalytic oxidizer installed, maintained, and operated in a satisfactory manner in the event that the catalytic oxidizer malfunctions during a batch until EU003 completes the batch. Upon completion of the batch, the permittee shall not operate EU003 until the catalytic oxidizer has been repaired. (R 336.1225, R 336.1702(a), R 336.1910)

IV. <u>DESIGN/EQUIPMENT PARAMETER(S)</u>

1. The permittee shall not operate EU003 unless the catalytic oxidizer is installed, maintained, and operated in a satisfactory manner, except as specified in SC III.1. Satisfactory operation of the catalytic oxidizer includes a minimum VOC capture efficiency of 95 percent (by weight), a minimum VOC destruction efficiency of 95 percent (by weight), and a minimum catalyst bed inlet temperature of 600°F (R 336.1205, R 336.1225, R 336.1702, R 336.1910)

- 2. Except as specified in SC III.1, the permittee shall install, calibrate, maintain, and operate in a satisfactory manner, a temperature monitoring device to continuously monitor and record the inlet and outlet temperatures of the catalytic oxidizer catalyst bed. (R 336.1205, R 336.1225, R 336.1702
- 3. Except as specified in SC III.1, upon bypass of the oxidizer, the permittee shall initiate an immediate shutdown, consistent with safe operating practices, of EU003. (R 336.1205, R 336.1224, R 336.1225, R 336.1702)

V. TESTING/SAMPLING

Records shall be maintained on file for a period of five years. (R 336.1201(3))

1. Upon request of the AQD District Supervisor, the permittee shall verify the VOC destruction efficiency of the catalytic oxidizer for EU003, by testing at owner's expense, in accordance with Department requirements. Testing shall be performed using an approved EPA Method listed in 40 CFR Part 60, Appendix A. An alternate method, or a modification to the approved EPA Method, may be specified in an AQD approved Test Protocol and must meet the requirements of the federal Clean Air Act, all applicable state and federal rules and regulations, and be within the authority of the AQD to make the change. No less than 30 days prior to testing, the permittee shall submit a complete test plan to the AQD Technical Programs Unit and District Office. The AQD must approve the final plan prior to testing. Verification of destruction efficiency includes the submittal of a complete report of the test results, including calculations demonstrating the destruction efficiency, to the AQD within 60 days following the last date of the test. (R 336.1205, R 336.1702, R 336.2001, R 336.2003, R 336.2004)

VI. MONITORING/RECORDKEEPING

Records shall be maintained on file for a period of five years. (R 336.1201(3))

- 1. The permittee shall complete all required calculations in a format acceptable to the AQD District Supervisor by the last day of the calendar month, for the previous calendar month, unless otherwise specified in any monitoring/recordkeeping special condition. (R 336.1205, R 336.702(a))
- 2. The permittee shall keep, using the tables in Appendix A or another method acceptable to the AQD District Supervisor, the following information on a monthly basis for FGOVENS:
 - a) For each variety of bread and bun produced at the facility, the VOC emission factor, determined using the method described in the USEPA Document No.453/R-92-017 "Alternative Control Technology Document for Bakery Oven Emissions, December 1992" for VOC emissions from bread fermentation or another method acceptable to the AQD District Supervisor.
 - b) The amount, in tons, of each variety of bread and each variety of buns produced per calendar month.
 - c) VOC mass emission calculations from bread and bun production, using the VOC emission factor for each variety of bread and bun produced, determining the monthly emission rate in tons per calendar month.
 - d) The monthly production weighted VOC emission factor for bread and for buns for each calendar month, using the monthly production records and monthly VOC emission rate records.
 - e) The total amount of bread produced, in tons, per calendar month and per 12-month rolling time period as determined at the end of each calendar month.
 - f) The total amount of buns produced, in tons, per calendar month and 12-month rolling time period as determined at the end of each calendar month.
 - g) VOC mass emission calculations from bread and bun production, using the monthly production weighted emission factor for buns, the monthly production weighted emission factor for bread, and the monthly production records, determining the monthly emission rate in tons per calendar month.
 - h) Total VOC mass emission calculations from bread and bun production determining the annual emission rate in tons per 12-month rolling time period as determined at the end of each calendar month.

The permittee shall keep all records on file at the facility and make them available to the Department upon request. (R 336.1205, R 336.1225, R 336.1702(a))

- 3. The permittee shall monitor and record, in a satisfactory manner, the inlet and outlet temperatures of the catalytic oxidizer catalyst bed, on a continuous basis, during operation of EU003. Temperature data recording shall consist of measurements made at equally spaced intervals, not to exceed 15 minutes per interval. The permittee shall keep all records on file and make them available to the Department upon request. (R 336.1205(1)(a)(ii), R 336.1225, R 336.1702)
- 4. The permittee shall keep, in a satisfactory manner, records of the number of oxidizer bypass episodes per calendar month and 12-month rolling time period as determined at the end of each calendar month. The permittee shall also record the duration, in hours, of each oxidizer bypass episode, a description of the malfunction, and any steps taken to remedy the malfunction. The permittee shall keep all records on file at the facility and make them available to the Department upon request. (R 336.1225, R 336.1702(a))

VII. REPORTING

- 1. Within 30 days after completion of the installation, construction, reconstruction, relocation, or modification authorized by this Permit to Install, the permittee or the authorized agent pursuant to Rule 204, shall notify the AQD District Supervisor, in writing, of the completion of the activity. Completion of the installation, construction, reconstruction, relocation, or modification is considered to occur not later than commencement of trial operation of the catalytic oxidizer. (R 336.1201(7)(a))
- 2. The permittee or the authorized agent pursuant to Rule 204, shall notify the AQD District Supervisor, in writing, of any malfunctions of the catalytic oxidizer. Notification includes the date, time, duration of the bypass, and actions taken to resolve the malfunction. (R 336.1201(7)(a))
