#### **GENERAL CONDITIONS**

- 1. The process or process equipment covered by this permit shall not be reconstructed, relocated, or modified, unless a Permit to Install authorizing such action is issued by the Department, except to the extent such action is exempt from the Permit to Install requirements by any applicable rule. (R 336.1201(1))
- 2. If the installation, construction, reconstruction, relocation, or modification of the equipment for which this permit has been approved has not commenced within 18 months, or has been interrupted for 18 months, this permit shall become void unless otherwise authorized by the Department. Furthermore, the permittee or the designated authorized agent shall notify the Department via the Supervisor, Permit Section, Air Quality Division, Michigan Department of Environment, Great Lakes, and Energy, P.O. Box 30260, Lansing, Michigan 48909-7760, if it is decided not to pursue the installation, construction, reconstruction, relocation, or modification of the equipment allowed by this Permit to Install. (R 336.1201(4))
- 3. If this Permit to Install is issued for a process or process equipment located at a stationary source that is not subject to the Renewable Operating Permit program requirements pursuant to Rule 210 (R 336.1210), operation of the process or process equipment is allowed by this permit if the equipment performs in accordance with the terms and conditions of this Permit to Install. (R 336.1201(6)(b))
- 4. The Department may, after notice and opportunity for a hearing, revoke this Permit to Install if evidence indicates the process or process equipment is not performing in accordance with the terms and conditions of this permit or is violating the Department's rules or the Clean Air Act. (R 336.1201(8), Section 5510 of Act 451, PA 1994)
- 5. The terms and conditions of this Permit to Install shall apply to any person or legal entity that now or hereafter owns or operates the process or process equipment at the location authorized by this Permit to Install. If the new owner or operator submits a written request to the Department pursuant to Rule 219 and the Department approves the request, this permit will be amended to reflect the change of ownership or operational control. The request must include all of the information required by subrules (1)(a), (b), and (c) of Rule 219 and shall be sent to the District Supervisor, Air Quality Division, Michigan Department of Environment, Great Lakes, and Energy. (R 336.1219)
- 6. Operation of this equipment shall not result in the emission of an air contaminant which causes injurious effects to human health or safety, animal life, plant life of significant economic value, or property, or which causes unreasonable interference with the comfortable enjoyment of life and property. (R 336.1901)
- 7. The permittee shall provide notice of an abnormal condition, start-up, shutdown, or malfunction that results in emissions of a hazardous or toxic air pollutant which continue for more than one hour in excess of any applicable standard or limitation, or emissions of any air contaminant continuing for more than two hours in excess of an applicable standard or limitation, as required in Rule 912, to the Department. The notice shall be provided not later than two business days after start-up, shutdown, or discovery of the abnormal condition or malfunction. Written reports, if required, must be filed with the Department within 10 days after the start-up or shutdown occurred, within 10 days after the abnormal condition or malfunction has been corrected, or within 30 days of discovery of the abnormal condition or malfunction, whichever is first. The written reports shall include all of the information required in Rule 912(5). (R 336.1912)
- 8. Approval of this permit does not exempt the permittee from complying with any future applicable requirements which may be promulgated under Part 55 of 1994 PA 451, as amended or the Federal Clean Air Act.
- 9. Approval of this permit does not obviate the necessity of obtaining such permits or approvals from other units of government as required by law.
- 10. Operation of this equipment may be subject to other requirements of Part 55 of 1994 PA 451, as amended and the rules promulgated thereunder.

- 11. Except as provided in subrules (2) and (3) or unless the special conditions of the Permit to Install include an alternate opacity limit established pursuant to subrule (4) of Rule 301, the permittee shall not cause or permit to be discharged into the outer air from a process or process equipment a visible emission of density greater than the most stringent of the following. The grading of visible emissions shall be determined in accordance with Rule 303 (R 336.1303). (R 336.1301)
  - a) A six-minute average of 20 percent opacity, except for one six-minute average per hour of not more than 27 percent opacity.
  - b) A visible emission limit specified by an applicable federal new source performance standard.
  - c) A visible emission limit specified as a condition of this Permit to Install.
- 12. Collected air contaminants shall be removed as necessary to maintain the equipment at the required operating efficiency. The collection and disposal of air contaminants shall be performed in a manner so as to minimize the introduction of contaminants to the outer air. Transport of collected air contaminants in Priority I and II areas requires the use of material handling methods specified in Rule 370(2). (R 336.1370)
- 13. The Department may require the permittee to conduct acceptable performance tests, at the permittee's expense, in accordance with Rule 1001 and Rule 1003, under any of the conditions listed in Rule 1001. (R 336.2001)

#### **II. MATERIAL LIMITS**

1. The permittee shall burn only pipeline quality natural gas in EUBOILER. (R 336.1205, R 336.1224, R 336.1225, R 336.1331, R 336.1702(a), 40 CFR 52.21(c) & (d), 40 CFR 63.11195(e))

#### III. PROCESS/OPERATIONAL RESTRICTIONS

- 1. No later than 45 days after the completion of installation of the equipment, the permittee shall submit to the AQD District Supervisor, for review and approval, a preventative maintenance / malfunction abatement plan (PM / MAP) for EUBOILER. After approval of the PM / MAP by the AQD District Supervisor, the permittee shall not operate EUBOILER unless the PM / MAP, or an alternate plan approved by the AQD District Supervisor, is implemented and maintained. The plan shall incorporate procedures recommended by the equipment manufacturer as well as incorporating standard industry practices. At a minimum, the plan shall include:
  - a) Identification of the equipment and, if applicable, air-cleaning device and the supervisory personnel responsible for overseeing the inspection, maintenance, and repair.
  - b) Description of the items or conditions to be inspected and frequency of the inspections or repairs.
  - c) Identification of the equipment and, if applicable, air-cleaning device, operating parameters that shall be monitored to detect a malfunction or failure, the normal operating range of these parameters and a description of the method of monitoring or surveillance procedures.
  - d) Identification of the major replacement parts that shall be maintained in inventory for quick replacement.
  - e) A description of the corrective procedures or operational changes that shall be taken in the event of a malfunction or failure to achieve compliance with the applicable emission limits.

If at any time the PM / MAP fails to address or inadequately addresses an event that meets the characteristics of a malfunction, the permittee shall amend the PM / MAP within 45 days after such an event occurs. The permittee shall also amend the PM / MAP within 45 days, if new equipment is installed or upon request from the AQD District Supervisor. - 1. The combined maximum design heat input capacity for EUBOILER shall not exceed 10 MMBtu per hour on a fuel heat input basis. (R 336.1205, 40 CFR Part 60 Subpart Dc)
- 2. The permittee shall not operate EUBOILER unless the low NO<sub>x</sub> burners are installed, maintained, and operated in a satisfactory manner. Satisfactory manner includes operating and maintaining the equipment in accordance with the MAP required in SC III.1. (R 336.1205, R 336.1910)
- 3. The permittee shall install, calibrate, maintain, and operate in a satisfactory manner a device to monitor and record the fuel use for EUBOILER on a monthly basis. (R 336.1205, 40 CFR 52.21, 40 CFR Part 60 Subparts Dc)

#### VI. MONITORING/RECORDKEEPING

Records shall be maintained on file for a period of five years. (R 336.1201(3))

- The permittee shall complete all required calculations in a format acceptable to the AQD District Supervisor by the last day of the calendar month, for the previous calendar month, unless otherwise specified in any monitoring/recordkeeping special condition. (R 336.1205, R 336.1331, 40 CFR 52.21(c) & (d))
- 2. The permittee shall keep monthly natural gas usage records, in a format acceptable to the AQD District Supervisor, indicating the amount of natural gas used, in cubic feet, on a calendar month basis, and a 12-month rolling time period basis. The records must indicate the total amount of natural gas used in EUBOILER. The permittee shall keep all records on file at the facility and make them available to the Department upon request. (R 336.1205, 40 CFR 52.21(c) & (d), 40 CFR Part 60 Subparts Dc)

#### VII. REPORTING

1. Within 10 days after completion of the installation, construction, reconstruction, relocation, or modification authorized by this Permit to Install, the permittee or the authorized agent pursuant to Rule 204, shall notify the AQD District Supervisor, in writing, of the completion of the activity. Completion of the installation, construction, reconstruction, relocation, or modification is considered to occur not later than commencement of trial operation of each boiler within EUBOILER. (R 336.1201(7)(a))

If at any time the plan fails to address or inadequately addresses odor management, the permittee shall amend the plan within 45 days after such an event occurs. The permittee shall also amend the plan within 45 days if new equipment is installed or upon request from the District Supervisor. The permittee shall submit the plan and any amendments to the plan to the AQD District Supervisor for review and approval. If the AQD does not notify the permittee within 90 days of submittal, the plan or amended plan shall be considered approved. Until an amended plan is approved, the permittee shall implement corrective procedures or operational changes to minimize odors. (R 336.1901)
- 5. No later than 90 days after the completion of installation of the equipment, the permittee shall submit to the AQD District Supervisor, for review and approval, Best Management Practices Plan (BMPP) for the use of ferric chloride to reduce the H<sub>2</sub>S concentration in the digester. The BMPP plan, at a minimum, should include the following:
  - a) A detailed plan for when ferric chloride should be added into the digester, including parameters that will be monitored, the amount and what frequency the ferric chloride will be added.
  - b) A detail plan explaining how the ferric chloride will reduce the H<sub>2</sub>S concentration in the digester.
  - c) The normal operating range of the H<sub>2</sub>S concentration in the digester

If at any time the BMPP fails to address or inadequately addresses the addition of ferric chloride into the digester, the permittee shall amend the PM / MAP within 45 days after such an event occurs. The permittee shall also amend the BMPP within 45 days, if new equipment is installed or upon request from the AQD District Supervisor. The permittee shall submit the BMPP and any amendments to the BMPP to the AQD District Supervisor for review and approval. If the AQD does not notify the permittee within 90 days of submittal, the BMPP or amended BMPP shall be considered approved. Until an amended plan is approved, the permittee shall implement corrective procedures or operational changes to achieve compliance with all applicable emission limits. (R 336.1205, 40 CFR 52.21(c) & (d)))

## IV. DESIGN/EQUIPMENT PARAMETER(S)

- 1. The permittee shall install, calibrate, maintain and operate in a satisfactory manner, acceptable to the AQD District Supervisor, a device to monitor and record the volumetric flow rate of digester gas burned in each emission unit within FGFLARE, on a continuous basis. (R 336.1205, R 336.1224, R 336.1225, R 336.1901, 40 CFR 52.21(c) & (d))
- 2. The permittee shall install, calibrate, maintain and operate in a satisfactory manner, acceptable to the AQD District Supervisor, a device to monitor and record the H<sub>2</sub>S concentration in EUFLARE and into the thermal oxidizer of EUGCU. The permittee shall monitor and record the concentrations for EUFLARE at a minimum of once per day and into the thermal oxidizer of EUGCU, on a continuous basis, during operation of EUGCU. (R 336.1205, R 336.1224, R 336.1225, R 336.1901, 40 CFR 52.21(c) & (d))
- 3. The permittee shall not operate EUGCU unless the thermal oxidizer is installed, maintained, and operated in a satisfactory manner, acceptable the AQD District Supervisor. Satisfactory manner includes maintaining a minimum combustion chamber temperature of 1450°F and operating and maintaining the equipment in accordance with the MAP required in SC III.3. (R 336.1205, R 336.1224, R 336.1225, R 336.1910, 40 CFR 52.21(c) & (d))
- 4.
