GENERAL CONDITIONS

- 1. The process or process equipment covered by this permit shall not be reconstructed, relocated, or modified, unless a Permit to Install authorizing such action is issued by the Department, except to the extent such action is exempt from the Permit to Install requirements by any applicable rule. (R 336.1201(1))
- 2. If the installation, construction, reconstruction, relocation, or modification of the equipment for which this permit has been approved has not commenced within 18 months, or has been interrupted for 18 months, this permit shall become void unless otherwise authorized by the Department. Furthermore, the permittee or the designated authorized agent shall notify the Department via the Supervisor, Permit Section, Air Quality Division, Michigan Department of Environment, Great Lakes, and Energy, P.O. Box 30260, Lansing, Michigan 48909-7760, if it is decided not to pursue the installation, construction, reconstruction, relocation, or modification of the equipment allowed by this Permit to Install. (R 336.1201(4))
- 3. If this Permit to Install is issued for a process or process equipment located at a stationary source that is not subject to the Renewable Operating Permit program requirements pursuant to Rule 210 (R 336.1210), operation of the process or process equipment is allowed by this permit if the equipment performs in accordance with the terms and conditions of this Permit to Install. (R 336.1201(6)(b))
- 4. The Department may, after notice and opportunity for a hearing, revoke this Permit to Install if evidence indicates the process or process equipment is not performing in accordance with the terms and conditions of this permit or is violating the Department's rules or the Clean Air Act. (R 336.1201(8), Section 5510 of Act 451, PA 1994)
- 5. The terms and conditions of this Permit to Install shall apply to any person or legal entity that now or hereafter owns or operates the process or process equipment at the location authorized by this Permit to Install. If the new owner or operator submits a written request to the Department pursuant to Rule 219 and the Department approves the request, this permit will be amended to reflect the change of ownership or operational control. The request must include all of the information required by subrules (1)(a), (b), and (c) of Rule 219 and shall be sent to the District Supervisor, Air Quality Division, Michigan Department of Environment, Great Lakes, and Energy. (R 336.1219)
- 6. Operation of this equipment shall not result in the emission of an air contaminant which causes injurious effects to human health or safety, animal life, plant life of significant economic value, or property, or which causes unreasonable interference with the comfortable enjoyment of life and property. (R 336.1901)
- 7. The permittee shall provide notice of an abnormal condition, start-up, shutdown, or malfunction that results in emissions of a hazardous or toxic air pollutant which continue for more than one hour in excess of any applicable standard or limitation, or emissions of any air contaminant continuing for more than two hours in excess of an applicable standard or limitation, as required in Rule 912, to the Department. The notice shall be provided not later than two business days after start-up, shutdown, or discovery of the abnormal condition or malfunction. Written reports, if required, must be filed with the Department within 10 days after the start-up or shutdown occurred, within 10 days after the abnormal condition or malfunction has been corrected, or within 30 days of discovery of the abnormal condition or malfunction, whichever is first. The written reports shall include all of the information required in Rule 912(5). (R 336.1912)
- 8. Approval of this permit does not exempt the permittee from complying with any future applicable requirements which may be promulgated under Part 55 of 1994 PA 451, as amended or the Federal Clean Air Act.
- 9. Approval of this permit does not obviate the necessity of obtaining such permits or approvals from other units of government as required by law.
- 10. Operation of this equipment may be subject to other requirements of Part 55 of 1994 PA 451, as amended and the rules promulgated thereunder.

- 11. Except as provided in subrules (2) and (3) or unless the special conditions of the Permit to Install include an alternate opacity limit established pursuant to subrule (4) of Rule 301, the permittee shall not cause or permit to be discharged into the outer air from a process or process equipment a visible emission of density greater than the most stringent of the following. The grading of visible emissions shall be determined in accordance with Rule 303 (R 336.1303). (R 336.1301)
 - a) A six-minute average of 20 percent opacity, except for one six-minute average per hour of not more than 27 percent opacity.
 - b) A visible emission limit specified by an applicable federal new source performance standard.
 - c) A visible emission limit specified as a condition of this Permit to Install.
- 12. Collected air contaminants shall be removed as necessary to maintain the equipment at the required operating efficiency. The collection and disposal of air contaminants shall be performed in a manner so as to minimize the introduction of contaminants to the outer air. Transport of collected air contaminants in Priority I and II areas requires the use of material handling methods specified in Rule 370(2). (R 336.1370)
- 13. The Department may require the permittee to conduct acceptable performance tests, at the permittee's expense, in accordance with Rule 1001 and Rule 1003, under any of the conditions listed in Rule 1001. (R 336.2001)

DESCRIPTION

A nonmetallic mineral crushing facility located at 21500 Northwestern Highway in Southfield, Michigan, consisting of crusher(s) and associated process equipment including grinding mills, drills, screening operations, bucket elevators, belt conveyors, loading and bagging operations, storage bins, enclosed truck or railcar loading stations, and any other material handling equipment operated at the site. Each crusher and screen shall be equipped with a water spray. A baghouse dust collector may alternatively be installed in lieu of water spray for any particular piece of equipment. Operation of the control equipment is required only when necessary to meet applicable emission limits.

II. MATERIAL LIMIT(S)

- The permittee shall not process any asbestos tailing or asbestos containing waste materials in FGCRUSHING pursuant to the National Emission Standards for Hazardous Air Pollutants, 40 CFR Part 61 Subpart M. (40 CFR Part 61 Subpart M)
- 2. The permittee shall only process nonmetallic mineral materials in FGCRUSHING, including, but not limited to concrete, rocks, and asphalt. (40 CFR 52.21 (c) & (d))
- 3. The permittee shall not process more than 100,000 tons of material through FGCRUSHING per 12-month rolling time period as determined at the end of each calendar month. (40 CFR 52.21 (c) & (d))

III. PROCESS/OPERATIONAL RESTRICTION(S)

1. The permittee shall not operate FGCRUSHING unless the program for continuous fugitive emissions control for all facility roadways, all trucks leaving the crusher area, the facility yard, all storage piles, and all material handling operations specified in Appendix A has been implemented and is maintained. (R 336.1371)

- 2. The permittee shall minimize track-out of material from the site onto adjacent public roadways. If necessary, the permittee shall use rumble strips, gravel pads, truck wheel washes, or other methods approved by the AQD District Supervisor to prevent fugitive dust emissions on public roadways adjacent to the facility due to material track-out from the facility. (40 CFR 52.21 (c) & (d))
- 3. The permittee shall comply with all provisions of the federal Standards of Performance for New Stationary Sources as specified in 40 CFR Part 60 Subparts A and OOO, as they apply to FGCRUSHING. (40 CFR Part 60 Subparts A & OOO)

IV. DESIGN/EQUIPMENT PARAMETER(S)

- 1. The permittee shall not operate any portion of FGCRUSHING unless the water sprays for each crusher and each screen are installed, maintained, and operated in a satisfactory manner to control visible emissions. (R 336.1910, 40 CFR 52.21 (c) & (d))
- 2. The permittee shall install and maintain a belt scale(s) on the transfer conveyor(s) portion of FGCRUSHING which continuously shows the daily throughput rate for the conveyor(s). (40 CFR 52.21 (c) & (d))

V. TESTING/SAMPLING

Records shall be maintained on file for a period of five years. (R 336.1201(3))

1. Within 60 days after achieving the maximum production rate, but not later than 180 days after commencement of trial operation, the permittee shall evaluate visible emissions from EUPROCESS, as required by federal Standards of Performance for New Stationary Sources, at owner's expense, in accordance 40 CFR Part 60 Subparts A and OOO. Visible emission observation procedures must have prior approval by the AQD Technical Programs Unit and District Office. No less than 30 days prior to testing, the permittee shall notify the AQD District Office of the date of the test. The permittee must submit a complete report of the test results to the AQD Technical Programs Unit and District Office within 45 days following the last date of the test. (R 336.1301, 40 CFR Part 60 Subparts A & OOO)

VI. MONITORING/RECORDKEEPING

Records shall be maintained on file for a period of five years. (R 336.1201(3))

- 1. The permittee shall complete all required calculations in a format acceptable to the AQD District Supervisor by the 15th day of the calendar month, for the previous calendar month, unless otherwise specified in any monitoring/recordkeeping special condition. (40 CFR 52.21 (c) & (d))
- 2. The permittee shall keep daily and monthly records of the amount of material processed through FGCRUSHING. Furthermore, the permittee shall calculate on a monthly basis, the yearly throughput rate based upon the most recent 12-month rolling time period. The permittee shall keep records of the amount of material processed on file and make them available to the Department upon request. (40 CFR 52.21 (c) & (d))
- 3. The permittee shall keep records, in a manner acceptable to the District Supervisor, of all watering/dust suppressant applications, sweepings, and clean-ups for the site roadways, plant yard and stockpiles as required by Appendix A. The permittee shall keep all records on file and make them available to the Department upon request. (R 336.1371)
- 4. The permittee shall perform daily inspections and record, in a format acceptable to the AQD District Supervisor, the condition of the process equipment and associated control devices prior to process start-up each calendar operating day. (R 336.1301, R 336.1910)
- 5. The permittee shall maintain a log of maintenance activities conducted and repairs made to FGCRUSHING and control devices. Maintenance and daily inspection records for the FGCRUSHING fugitive dust control equipment shall also be included. The permittee shall keep all records, in a format acceptable to the AQD District Supervisor, on file and make them available to the Department upon request. (R 336.1301, R 336.1910, 40 CFR 52.21 (c) & (d))

VII. REPORTING

- 1. Within 30 days after completion of the installation, construction, reconstruction, relocation, or modification authorized by this Permit to Install, the permittee or the authorized agent pursuant to Rule 204, shall notify the AQD District Supervisor, in writing, of the completion of the activity. Completion of the installation, construction, reconstruction, relocation, or modification is considered to occur not later than commencement of trial operation of FGCRUSHING. (R 336.1201(7)(a))
- 2. The permittee shall provide written notification of construction and operation to comply with the federal Standards of Performance for New Stationary Sources, 40 CFR 60.7. The permittee shall submit this notification to the AQD District Supervisor within the time frames specified in 40 CFR 60.7. (40 CFR 60.7)
- 3. The permittee shall submit notification to the AQD District Supervisor at least 10 days prior to relocating FGCRUSHING to this site; however, if electronic notification is used, the notification shall be submitted at least 5 days before the change of location or 2 business days if the owner provided the AQD District Supervisor a list of anticipated operating locations for that calendar year at least 10 days before the change of location and if the proposed location is on that list. (Act 451 324.5505, 40 CFR 52.21 (c) & (d))

VIII. STACK/VENT RESTRICTION(S)

NA

IX. OTHER REQUIREMENT(S)

1. This permit shall be terminated on or before January 1, 2023. (R 336.1201(3))

APPENDIX A

Fugitive Dust Control Plan

I. Plant

The drop distance at each transfer point throughout the plant shall be reduced to the minimum the equipment can achieve.

II. Truck Traffic

- (a) On-site vehicles shall be loaded to prevent their contents from dropping, leaking, blowing, or otherwise escaping. This shall be accomplished by loading so that no part of the load shall come in contact within six inches of the top of any sideboard, side panel or tailgate; otherwise, the truck shall be tarped.
- (b) OUT-GOING TRUCKS: All trucks leaving the crusher area with product will be required to cover their loads prior to leaving the site. A sign shall be posted to advise drivers of this requirement.
- (c) Track out on to public roadways from trucks leaving the crusher area shall be swept on a daily basis and shall be done in a manner so as to minimize the reintroduction of dust to the outer air and meet an opacity limit of five percent.
- (d) The permittee shall record, in a manner acceptable to the AQD District Supervisor, the date and time of each track out clean up, which shall be kept on file for the most recent five-year period and be made available to the AQD upon request.

III. Site Roadways and the Plant Yard

- (a) The dust on the roadways and the plant yard in the crusher area shall be controlled by applications of water, calcium chloride or other acceptable and approved fugitive dust control compounds, sweeping, vacuuming, or other acceptable and approved fugitive dust control methods. Applications of dust suppressants shall be done as often as necessary to meet an opacity limit of five percent. Sweeping and clean-up activities shall be done in a manner so as to minimize the reintroduction of dust to the outer air and meet an opacity limit of five percent.
- (b) All paved roadways and the plant yard in the crusher area shall be swept as often as necessary to meet all applicable emission limits between applications. Sweeping and clean-up activities shall be done in a manner so as to minimize the reintroduction of dust to the outer air and meet an opacity limit of five percent.
- (c) Any material spillage on roads of material from the crushing operation shall be cleaned up immediately. Sweeping and clean-up activities shall be done in a manner so as to minimize the reintroduction of dust to the outer air and meet an opacity limit of five percent.
- (d) The permittee shall record, in a manner acceptable to the AQD District Supervisor, the date and time of all applications of dust suppressants and roadway and the plant yard sweepings, which shall be kept on file for the most recent five-year period and be made available to the AQD upon request.

IV. Storage Piles

- (a) Stockpiling of all nonmetallic minerals shall be performed to minimize drop distance and control potential dust problems.
- (b) Stockpiles shall be watered on an as needed basis in order to meet an opacity limit of five percent. Equipment to apply water or dust suppressant shall be available at the site, or on call for use at the site, within a given operating day.

(c) The permittee shall record, in a manner acceptable to the AQD District Supervisor, all applications of dust suppressant, which shall be kept on file for the most recent five-year period and be made available to the AQD upon request.

V. AQD/EGLE Inspection

The provisions and procedures of this plan are subject to adjustment by written notification from the AQD, if following an inspection, the AQD finds the fugitive dust requirements and/or the permitted opacity limits are not being met.
