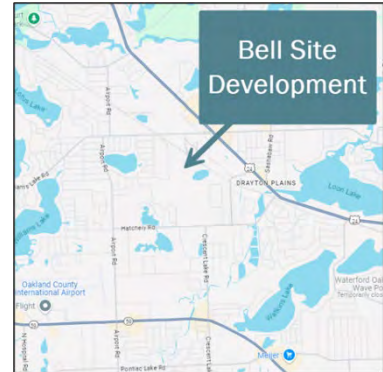

EGLE is holding a public comment period regarding DTE Belle River's proposed Permit to Install from **May 8** until **June 24, 2025**. Air permit application No. APP-2024-0273 is a request to convert the existing coal-fired power plant to natural gas by refueling the utility boilers, replacing the auxiliary boilers with natural gas-fired counterparts, and installing supporting fuel gas heaters (powered by natural gas).

WITHDRAWN Envergia, Inc. – APP-2024-0279

Envergia, Inc. has withdrawn its air permit to install application No. APP-2024-0279. The application was a request to install and operate a lithium-ion battery material recovery facility, which had a proposed location of 12601 Southfield Road in Detroit, Michigan. Based on this request, the Michigan Department of Environment, Great Lakes, and Energy Air Quality Division is closing the comment period and canceling the virtual public meeting and hearing originally scheduled for Tuesday, May 20, 2025.

| Technical Fact Sheet | Includes the technical evaluation of the permit application and how the proposed project meets the regulations that apply. |
| Notice of Hearing | Legal notice for the comment period. |
| Proposed Permit Terms and Conditions | Includes the proposed permit requirements based on a thorough review of the application. |
| Interested Party Letter | People who have indicated their interest in this facility are notified comment period has started. |
| Company Letter | Informs the company the public comment period has started. |
