The U.S. Environmental Protection Agency has reviewed the draft initial Renewable Operating Permit for Marquette Board of Light & Power - Marquette Energy Center (State Registration Number: P0668), located in Marquette, Michigan. To ensure that the source meets Federal Clean Air Act requirements, that the permit will provide necessary information so that the basis of the permit decision is transparent and readily accessible to the public, and that the permit record provides adequate support for the decision, EPA has the following comment:

The draft permit and the Staff Report do not address potentially applicable requirements pursuant to the Clean Air Act Acid Rain Program. Please review the Acid Rain Program's applicability and exemption provisions (40 CFR 72.6 and 72.7) and include the appropriate applicable requirements in the permit. It is likely that the source is subject to the new unit exemption provisions in 40 CFR 72.7. Note that 40 CFR 72.7(b)(3) includes specific permit content requirements for the new unit exemption provisions.
