VIOLATION NOTICE

On April 17, 2018, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of Huntington Cleaners, 8775 Capital Street, Oak Park, Michigan. The purpose of this inspection was to determine Huntington Cleaners' compliance with the requirements of the federal Clean Air Act and Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451).

Specifically, this dry cleaner is subject to the federal National Perchloroethylene Air Emission Standards for Dry Cleaning Facilities, Title 40 of the Code of Federal Regulations (CFR), Part 63, Subpart M and the Public Health Code, 1978 PA 368, as amended, Dry Cleaning Establishment Rules Utilizing Class I, II, III, and IV Solvents. According to our investigation, Huntington Cleaners owns the facility and T&S Mechanical, Inc. installed the equipment at the facility. The Dry Cleaning Establishment Rules Utilizing Class I, II, III, and IV Solvents holds both the owner and the installer equally liable for violations.

During the inspection, staff observed the following:

	R 325.17202(a)	The dry cleaning establishment was modified without prior notification, plans, or approval (installed a perchloroethylene dry cleaning machine).
	R 325.17202(b)	The dry cleaning license was not applied for and the license fee was not paid.
	R 325.17202(c)	Local approval was not provided prior to installation of the dry cleaning machine.

Process Description	Rule/Permit Condition Violated	Comments
	R 325.17701(2)	General exhaust ventilation shall be provided in a dry cleaning machine room with a minimum capacity of 1 complete air change every 5 minutes.
	R 325.17714	Provide an approved organic vapor respirator and keep it near the dry cleaning machine in a sealed container.


Also, we recommend that you store the waste in a secure location, protected from the elements, and on an impervious surface.

Please initiate actions necessary to correct the cited violations and submit a written response to this Violation Notice by May 16, 2018 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If Huntington Cleaners and T&S Mechanical, Inc. believe the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.
