SECOND VIOLATION NOTICE

On May 9, 2019 and July 24, 2019, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD), conducted an inspection of Lemon Fresh Laundry & Drycleaning located at 402 East 8th Street, Holland. The purpose of this inspection was to determine compliance with the requirements of the federal Clean Air Act and Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451).

Specifically, this Dry Cleaner is subject to the federal National Perchloroethylene Air Emission Standards for Dry Cleaning Facilities, Title 40 of the Code of Federal Regulations, Part 63, Subpart M and the Public Health Code, 1978 PA 368, as amended, Dry Cleaning Establishment Rules Utilizing Class I, II, III, and IV Solvents.

On May 24, 2019, the AQD sent the company a Violation Notice citing violations discovered as a result of the inspection and requested your written response by June 14, 2019. A copy of that letter is enclosed for your reference. As of this date, we have not received your response.

Please be advised that failure to respond in writing and identifying actions the company will take or has taken to resolve the cited violations may result in escalated enforcement actions by the AQD. Please provide the information requested in our May 24, 2019 letter by October 7, 2019 which corresponds to 14 days from the date of this letter.

Be further advised that issuance of this Violation Notice does not preclude or limit EGLE's ability to initiate any other enforcement action under state or federal law as appropriate.
