SECOND VIOLATION NOTICE

On June 4, 2019, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD), conducted an inspection of Shelby's Extraordinaire, LLC, Dry Cleaners (Company), located at 15050 Fenkell Avenue, Detroit, Michigan. The purpose of the inspection was to determine the Company's compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); and the Air Pollution Control Rules.

On June 17, 2019, the AQD sent the Company a Violation Notice (VN) citing violations of the federal National Perchloroethylene Air Emissions Standards for Dry Cleaning Facilities, Title 40 of the Code of Federal Regulations Part 63, Subpart M and the Public Health Code, 1978 PA 368, as amended, Dry Cleaning Establishment Rules Utilizing Class I, II, III, and IV Solvents. These violations were discovered because of the inspection and requested the Company's written response by July 8, 2019. A copy of this VN has been enclosed for your reference. As of the date of this letter, the AQD has not received the Company's written response to the cited violations.

Please be advised that failure to respond in writing and identifying actions the Company will take or has taken to resolve the cited violations may result in an escalated enforcement action by the AQD. Please provide the information requested in the VN dated June 17, 2019 by **July 29, 2019**, which corresponds to 14 days from the date of this letter.

The Company's written response must be submitted to Mr. Jong Yu, at EGLE, AQD, 525 West Allegan Street, Lansing, Michigan 48909-7760 and must include a copy to Ms. Jenine Camilleri, Enforcement Unit Supervisor at EGLE, AQD, P.O. Box 30260, Lansing, Michigan 48909-7760.
